Transaction Summary

The transaction closed on May 30 2018 and matures in Apr 2031. The pool's current aggregate principal balance is \$873.4 million compared to \$901.3 million at close.

The largest loan of the pool (9.6%) is secured by CoolSprings Galleria located in metropolitan area. Occupancy at the subject was 96%. The major tenants included Belk's (28.60%) and H&M (3.69%). The second largest loan of the pool (10.2%) is secured by One Dulles Tower located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The largest tenant was Amazon.com (100.00%). The third largest loan of the pool (8.6%) is secured by Fair Oaks Mall - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 91%. The major tenants included Macy's (27.60%) and XXI Forever (6.60%).

age (WALA) were 4.44% and 48 months as of 04/15/2022, respectively. There are a total of 63 loans and 95 properties in the portfolio. The appraisal LTV was approximately 49.4% compared to the Original loan to value (LTV), which was approximately 50.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.81x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)




Local Distribution





There were 5 assets (3.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 10 assets (8.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (17.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (34.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (20.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (13.6% of total balance) with NCF DSCR between 2.5x and 3.0x and 3 assets (3.1% of total balance) with NCF DSCR between 3.0x and 3.5x. 



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
