## **Transaction Summary**

The transaction closed on Aug 02 2018 and matures in Apr 2031. The pool's current aggregate principal balance is \$892.7 million compared to \$944.7 million at close.

The largest loan of the pool (10.5%) is secured by 1745 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Penguin Random House LLC (88.19%) and PDT Partners LLC (7.81%). The second largest loan of the pool (9.5%) is secured by Griffin Portfolio II located in Elgin, IL-17.44% metropolitan area. Occupancy at the subject was 100%. The major tenants included 3M COMPANY (35.88%) and Amazon.com (31.41%). The third largest loan of the pool (3.1%) is secured by Pfizer Building located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was Pfizer, Inc. (100.00%).

respectively. There are a total of 62 loans and 89 properties in the portfolio. The appraisal LTV was approximately 53.5% compared to the Original loan to value (LTV), which was approximately 54.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.60% and 46 months as of 04/15/2022,





## Occupancy Distribution (%)













# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
