Transaction Summary

The transaction closed on Sep 27 2018 and matures in Sep 2043. The pool's current aggregate principal balance is \$1357.2 million compared to \$1380.2 million at close.

The largest loan of the pool (7.4%) is secured by 685 Fifth Avenue Retail located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Coach (85.22%) and Stuart Weitzman Outlet (10.98%). The second largest loan of the pool (7.4%) is secured by Aventura Mall - Trust located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 94%. The major tenants included JCPenney (15.90%) and AMC Theatres (6.50%). The third largest loan of the pool (5.6%) is secured by Park 80 West located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 86%. The major tenants included CBRE (5.35%) and Assigned Risk Solutions Ltd. (5.30%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.62% and 28 months as of 12/15/2020, respectively. There are a total of 62 loans and 141 properties in the portfolio. The appraisal LTV was approximately 54.4% compared to the Original loan to value (LTV), which was approximately 53.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.02x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 2% to 63% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 2% to 63%. There were 4 assets (1% of total balance) with NOI debt yield between 2% and 4%, 4 assets (2% of total balance) with NOI debt yield between 4% and 6%, 5 assets (10% of total balance) with NOI debt vield between 6% and 8%. 20 assets (30% of total balance) with NOI debt yield between 8% and 10%, 12 assets (22% of total balance) with NOI debt yield between 10% and 12%, 7 assets (21% of total balance) with NOI debt yield between 12% and 14%, 4 assets (2% of total balance) with NOI debt yield between 14% and 16%, 3 assets (8% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 28% and 30% and 1 assets (0% of total balance) with NOI debt yield between 62% and 64%.

NCF DSCR ranged from 0.0x to 4.0x. There were 4 assets (0.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 8 assets (8.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (12.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 19 assets (33.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (23.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (12.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (5.9% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (3.7% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 2.0x.







DSCRs ranged from 0.0x to 4.0x.There are 4 assets (0.9% of total balance) with DSCR between 0.0x and 0.5x, 8 assets (8.3% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (6.5% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (23.7% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (24.5% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (26.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (3.7% of total balance) with DSCR between 3.0x and 3.5x and 3 assets (5.9% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.2x.

There are 2 assets (8.7% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (1.4% of total balance) that have maturity dates between 2024/7 and 2024/12, 7 assets (11.8% of total balance) that have maturity dates between 2028/1 and 2028/6, 51 assets (75.0% of total balance) that have maturity dates between 2028/7 and 2028/12 and 1 assets (3.1% of total balance) that have maturity dates between 2043/7 and 2043/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
