## Transaction Summary

The transaction closed on Feb 21 2019 and matures in Feb 2029. The pool's current aggregate principal balance is \$968.7 million compared to \$975.2 million at close.

The largest loan of the pool (7.4%) is secured by One AT&T located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 100%. The largest tenant was AT&T (100.00%). The second largest loan of the pool (7.1%) is secured by Southeast Hotel Portfolio located in metropolitan area. Occupancy at the subject was 80%. The third largest loan of the pool (6.7%) is secured by Millennium Partners Portfolio - Trust located in New York-Jersey City-White Plains, NY-NJ-44.82% Boston, MA-25.76% San Francisco-Redwood City-South San Francisco, CA-12.00% Washington-Arlington-Alexandria, DC-VA-MD-WV-9.17% Miami-Miami Beach-Kendall, FL-8.24% metropolitan area. Occupancy at the subject was 100%. The major tenants included Equinox (26.03%) and Loews Theater (14.30%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.85% and 22 months as of 10/15/2020, respectively. There are a total of 69 loans and 115 properties in the portfolio. The appraisal LTV was approximately 57.1% compared to the Original loan to value (LTV), which was approximately 57.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.31x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.

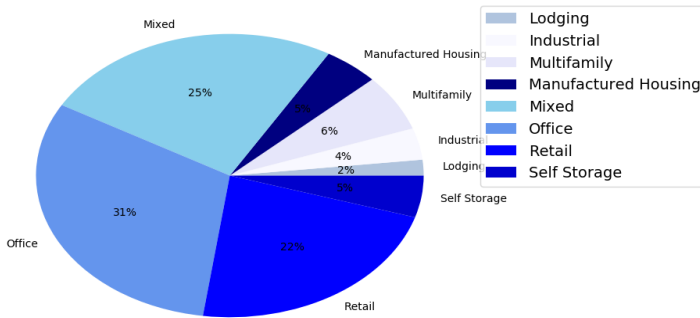

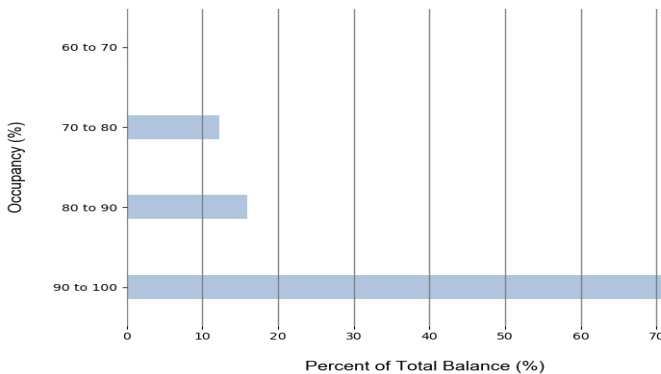

Occupancy Distribution (%)

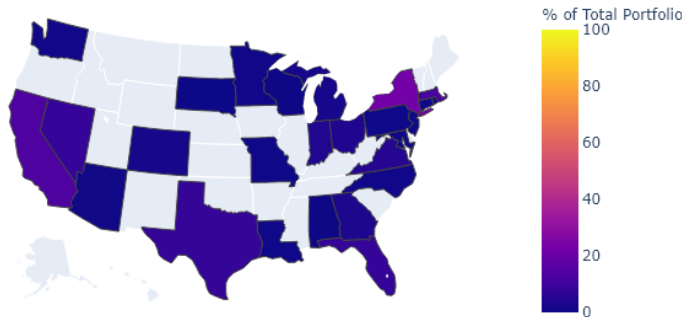

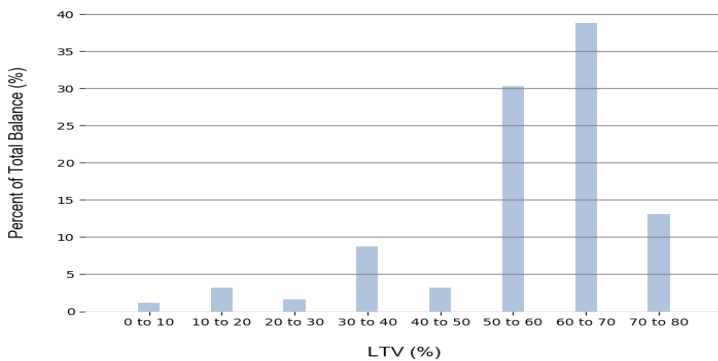
Local Distribution

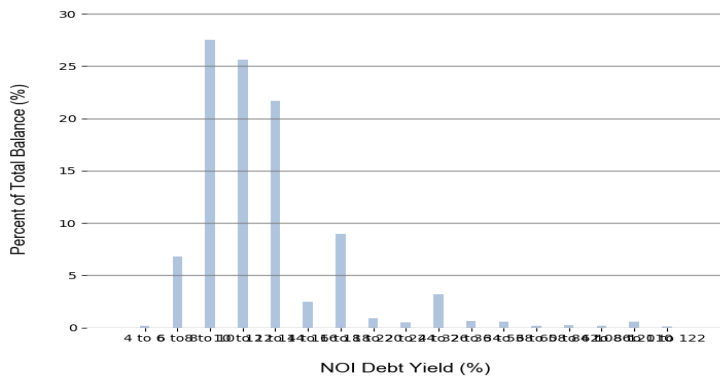

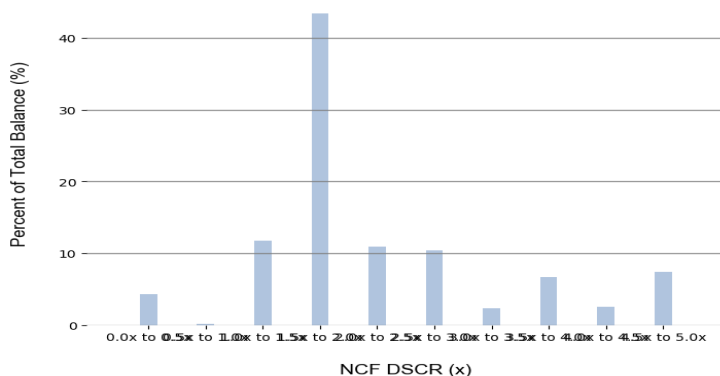
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

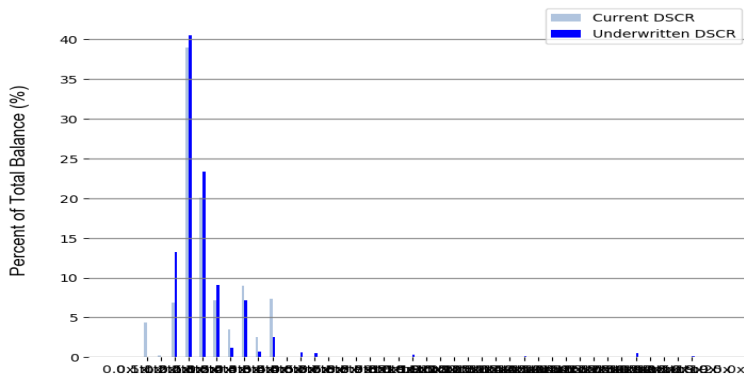

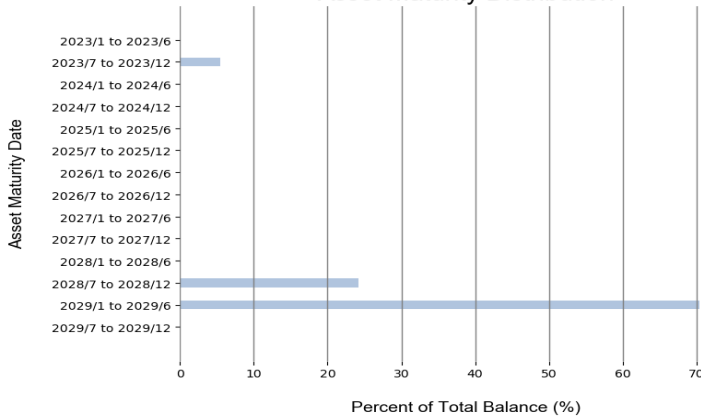
**DSCR Distribution (x)**

There are 14 assets (4.3% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.2% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (6.8% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (38.9% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (20.1% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (7.2% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (3.5% of total balance) with DSCR between 3.0x and 3.5x, 3 assets (9.0% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (2.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (7.4% of total balance) with DSCR between 4.5x and 5.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
