Transaction Summary

The transaction closed on Apr 04 2019 and matures in Apr 2029. The pool's current aggregate principal balance is \$824.8 million compared to \$833.3 million at close.

The largest loan of the pool (7.7%) is secured by Newport Office Center VI located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included JPMorgan Chase (77.09%) and The Depository Trust & Clearing Corporation (19.40%). The second largest loan of the pool (7.6%) is secured by 350 Rhode Island South located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 84%. The major tenants included SAMSARA Networks (60.67%) and Service Employees International Union (18.29%). The third largest loan of the pool (6.8%) is secured by Tower 28 - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.62% and 37 months as of 04/15/2022, respectively. There are a total of 49 loans and 239 properties in the portfolio. The appraisal LTV was approximately 54.7% compared to the Original loan to value (LTV), which was approximately 55.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.92x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.

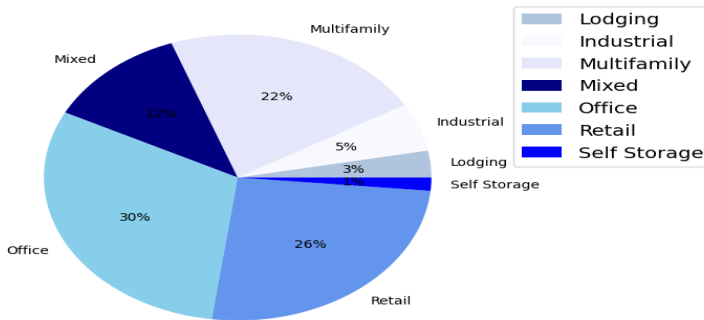

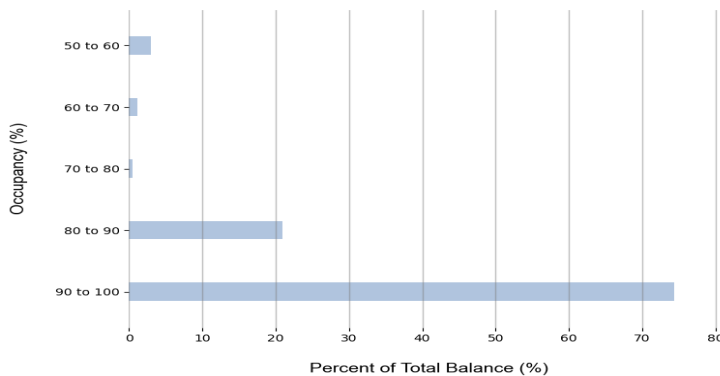

Occupancy Distribution (%)

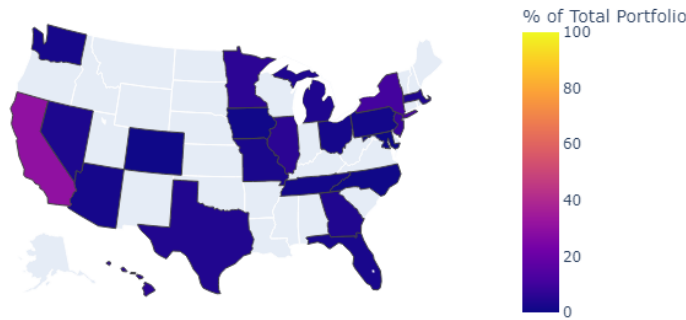

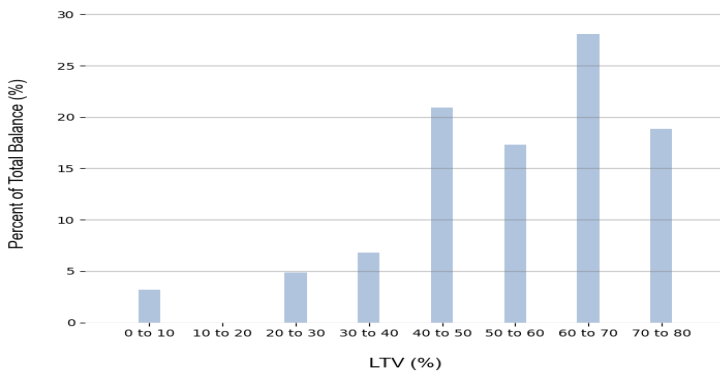
Local Distribution

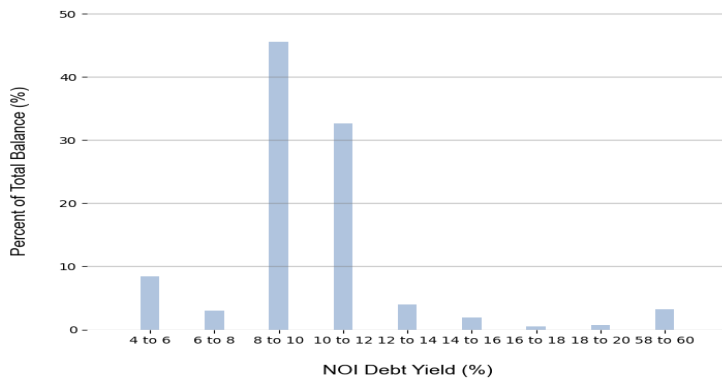

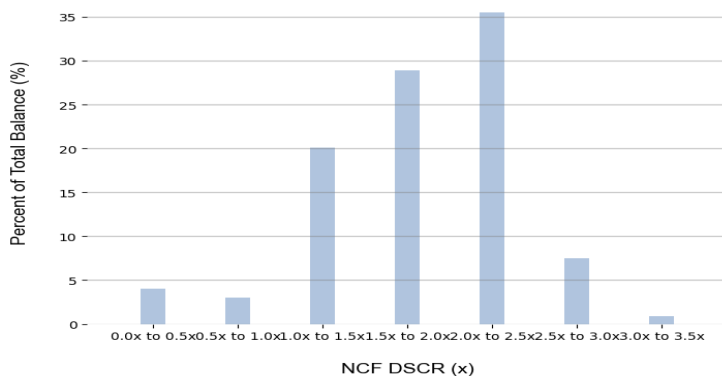
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 59% with a weighted average NOI debt yield of 9.9%. NOI debt yield ranged from 4% to 59%. There were 2 assets (8% of total balance) with NOI debt yield between 4% and 6%, 2 assets (3% of total balance) with NOI debt yield between 6% and 8%, 18 assets (46% of total balance) with NOI debt yield between 8% and 10%, 16 assets (33% of total balance) with NOI debt yield between 10% and 12%, 6 assets (4% of total balance) with NOI debt yield between 12% and 14%, 2 assets (2% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20% and 1 assets (3% of total balance) with NOI debt yield between 58% and 60%.

Net Cash Flow DSCR (x)

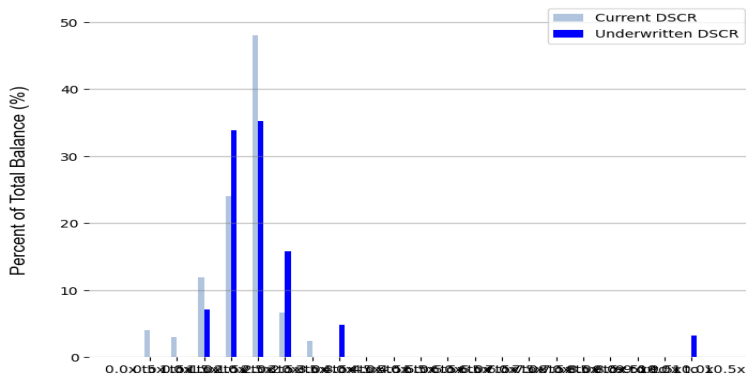

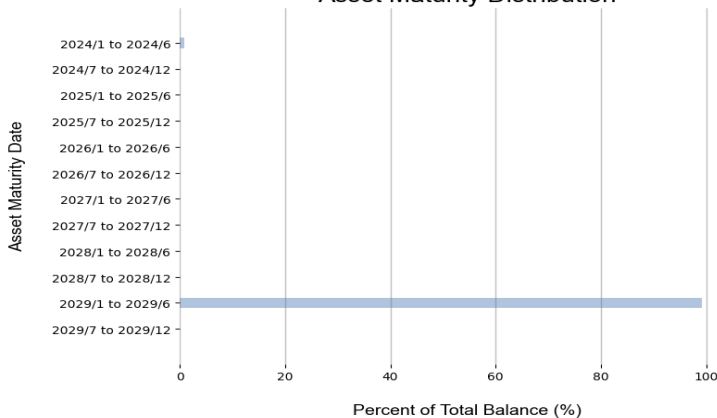
DSCR Distribution (x)

There are 2 assets (4.0% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (3.0% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (11.9% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (24.0% of total balance) with DSCR between 1.5x and 2.0x, 16 assets (48.0% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (6.7% of total balance) with DSCR between 2.5x and 3.0x and 3 assets (2.4% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
