#### **Transaction Summary**

The transaction closed on Aug 08 2019 and matures in Jun 2034. The pool's current aggregate principal balance is \$1291.7 million compared to \$1303.1 million at close.

The largest loan of the pool (7.7%) is secured by Grand Canal Shoppes - Trust located in metropolitan area. Occupancy at the subject was 83%. The major tenants included Venetian Casino Resort (5.55%) and The Venetian Resort (Showroom / Theater) (5.12%). The second largest loan of the pool (6.7%) is secured by Waterford Lakes Town Center located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Regal Cinemas (12.47%) and Best Buy (6.67%). The third largest loan of the pool (6.6%) is secured by 350 Bush Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Twitch Interactive Inc (48.00%) and Atlassian Inc (37.47%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.05% and 34 months as of 04/15/2022, respectively. There are a total of 73 loans and 76 properties in the portfolio. The appraisal LTV was approximately 57.8% compared to the Original loan to value (LTV), which was approximately 56.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.08x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





## Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 0% to 45% with a weighted average NOI debt yield of 9.8%. NOI debt yield ranged from 0% to 45%. 



DSCRs ranged from 0.0x to 6.0x. There are 8 assets (6.7% of total balance) with DSCR between 0.0x and 0.5x, 12 assets (4.3% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (8.4% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (17.0% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (25.9% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (20.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (4.7% of total balance) with DSCR between 3.0x and 3.5x, 4 assets (11.1% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.9% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (0.7% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.2x.

There are 30 assets (606.8% of total balance) that have maturity dates between 2029/1 and 2029/6, 42 assets (634.9% of total balance) that have maturity dates between 2029/7 and 2029/12 and 1 assets (50.0% of total balance) that have maturity dates between 2034/1 and 2034/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
