Transaction Summary

The transaction closed on Oct 23 2019 and matures in Oct 2044. The pool's current aggregate principal balance is \$1177.8 million compared to \$1181.1 million at close.

The largest loan of the pool (9.8%) is secured by Park Tower at Transbay located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Facebook, Inc. (66.54%) and Facebook, Inc. (32.32%). The second largest loan of the pool (9.3%) is secured by 230 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Discovery Communicat (94.80%) and JPMorgan Chase (3.26%). The third largest loan of the pool (7.7%) is secured by Domain Tower located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was INDEED INC. (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.63% and 15 months as of 12/15/2020, respectively. There are a total of 49 loans and 87 properties in the portfolio. The appraisal LTV was approximately 61.8% compared to the Original loan to value (LTV), which was approximately 60.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.89x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.








Local Distribution





Most recent net operating income debt yield ranged from 2% to 19% with a weighted average NOI debt yield of 9.2%. NOI debt yield ranged from 2% to 19%. There were 1 assets (6% of total balance) with NOI debt yield between 2% and 4%, 4 assets (6% of total balance) with NOI debt yield between 4% and 6%, 9 assets (22% of total balance) with NOI debt yield between 6% and 8%, 12 assets (31% of total balance) with NOI debt yield between 8% and 10%, 9 assets (20% of total balance) with NOI debt yield between 10% and 12%, 8 assets (11% of total balance) with NOI debt yield between 12% and 14%, 3 assets (2% of total balance) with NOI debt yield between 14% and 16%, 2 assets (3% of total balance) with NOI debt yield between 16% and 18% and 1 assets (0% of total balance) with NOI debt yield between 18% and 20%.

There were 1 assets (1.3% of total balance) with NCF DSCR between -1.0x and -0.5x, 1 assets (9.3% of total balance) with NCF DSCR between -0.5x and 0.0x, 8 assets (7.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (0.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 6 assets (8.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 8 assets (13.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (36.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (13.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 4 assets (10.2% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.1% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from -1.0x to 5.5x.There are 1 assets (1.3% of total balance) with DSCR between -1.0x and -0.5x, 1 assets (9.3% of total balance) with DSCR between -0.5x and 0.0x, 7 assets (6.2% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.9% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (5.9% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (15.6% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (28.8% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (20.5% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (8.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.1% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
