## **Transaction Summary**

The transaction closed on Nov 15 2019 and matures in Nov 2034. The pool's current aggregate principal balance is \$1198.6 million compared to \$1202.5 million at close.

The largest loan of the pool (9.6%) is secured by Park Tower at Transbay located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Facebook, Inc. (66.54%) and Facebook, Inc. (32.32%). The second largest loan of the pool (9.2%) is secured by 230 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Discovery Communicat (94.80%) and JPMorgan Chase (3.26%). The third largest loan of the pool (7.4%) is secured by Midtown Center - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included Fannie Mae (82.23%) and WeWork (12.67%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.48% and 14 months as of 12/15/2020, respectively. There are a total of 58 loans and 131 properties in the portfolio. The appraisal LTV was approximately 52.8% compared to the Original loan to value (LTV), which was approximately 52.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.93x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 97%.















# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
