Transaction Summary

The transaction closed on Nov 15 2019 and matures in Nov 2034. The pool's current aggregate principal balance is \$1194.2 million compared to \$1202.5 million at close.

The largest loan of the pool (9.6%) is secured by Park Tower at Transbay located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Facebook, Inc. (66.54%) and Facebook, Inc. (32.32%). The second largest loan of the pool (9.2%) is secured by 230 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Discovery Communicat (95.27%) and JPMorgan Chase (2.49%). The third largest loan of the pool (7.4%) is secured by Midtown Center - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included Fannie Mae (82.23%) and WeWork (12.67%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.48% and 29 months as of 03/15/2022, respectively. There are a total of 58 loans and 131 properties in the portfolio. The appraisal LTV was approximately 52.7% compared to the Original loan to value (LTV), which was approximately 52.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.20x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 95%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 45% with a weighted average NOI debt yield of 8.3%. NOI debt yield ranged from 0% to 45%. There were 8 assets (4.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (10.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (7.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 13 assets (24.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (19.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 6 assets (23.3% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (7.4% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (0.2% of total balance) with NCF DSCR between 4.5x and 5.0x. 



There are 7 assets (3.5% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (11.2% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (3.5% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (21.2% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (20.7% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.0% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (22.1% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (8.7% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.2% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
