Transaction Summary

The transaction closed on Dec 10 2019 and matures in Aug 2034. The pool's current aggregate principal balance is \$1284.6 million compared to \$1287.3 million at close.

The largest loan of the pool (8.2%) is secured by Century Plaza Towers - Trust located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 93%. The major tenants included Bank of America (6.20%) and Manatt Phelps (4.80%). The second largest loan of the pool (7.8%) is secured by Jackson Park - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The third largest loan of the pool (7.8%) is secured by Park Tower at Transbay located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Facebook, Inc. (66.54%) and Facebook, Inc. (32.32%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.52% and 13 months as of 12/15/2020, respectively. There are a total of 47 loans and 100 properties in the portfolio. The appraisal LTV was approximately 55.9% compared to the Original loan to value (LTV), which was approximately 56.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.67x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 95%.

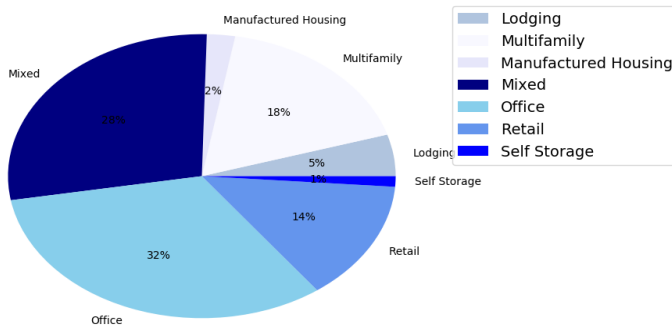

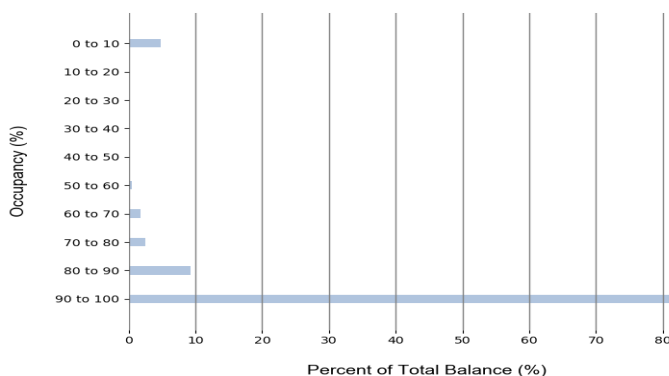

Occupancy Distribution (%)

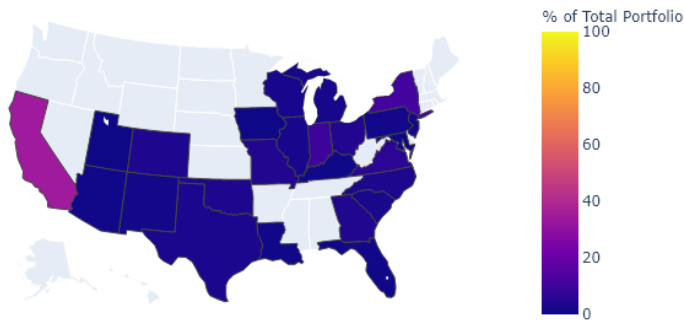

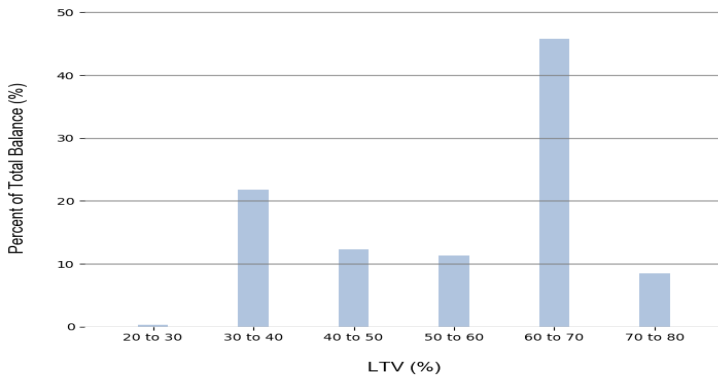
Local Distribution

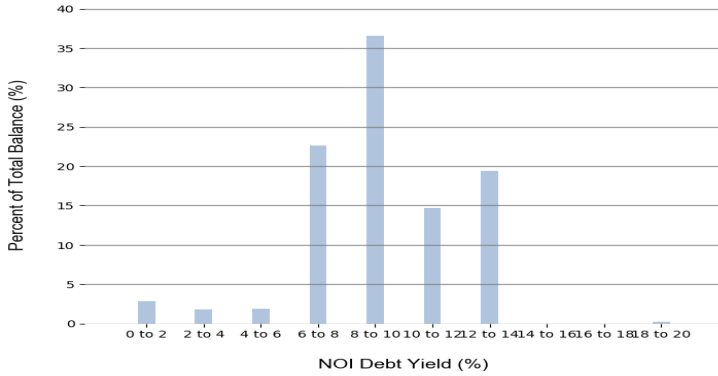

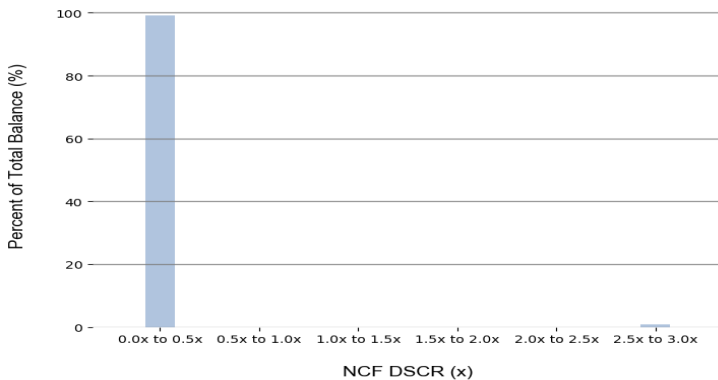
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

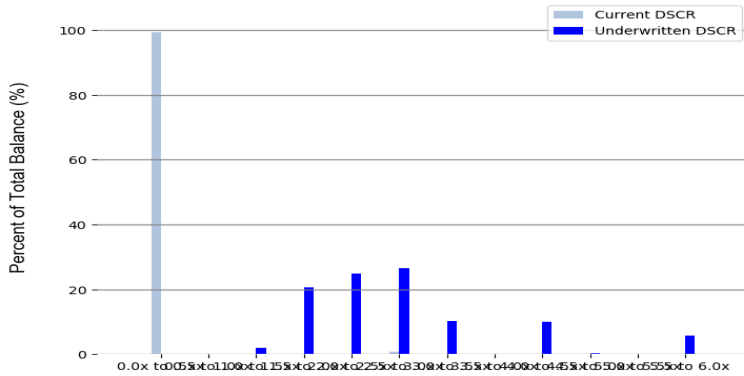

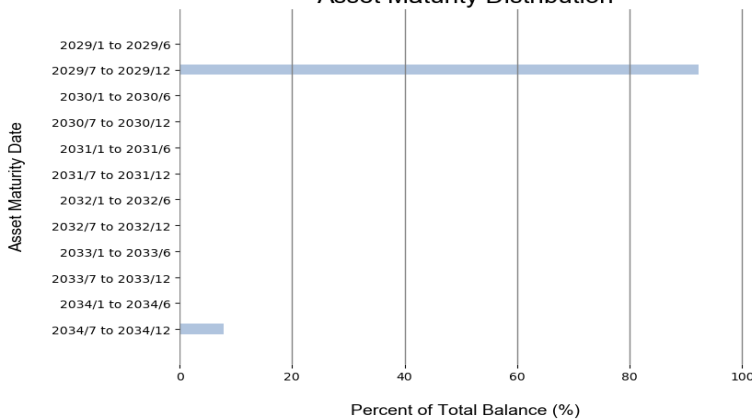
DSCR Distribution (x)

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
