Transaction Summary

The transaction closed on Feb 13 2020 and matures in Aug 2034. The pool's current aggregate principal balance is \$1632.4 million compared to \$1634.5 million at close.

The largest loan of the pool (6.1%) is secured by 55 Hudson Yards - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Point72 (23.22%) and Milbank, Tweed, Hadley & McCloy (20.08%). The second largest loan of the pool (6.1%) is secured by 1633 Broadway - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Allianz Asset Mgmt of America (12.53%) and WMG Acquisition Corp (11.47%). The third largest loan of the pool (6.1%) is secured by Bellagio Hotel and Casino - Trust located in metropolitan area. Occupancy at the subject was 95%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.43% and 10 months as of 10/15/2020, respectively. There are a total of 77 loans and 97 properties in the portfolio. The appraisal LTV was approximately 51.5% compared to the Original loan to value (LTV), which was approximately 51.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.85x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





Occupancy Distribution (%)




Local Distribution





DSCRs ranged from 0.0x to 3.0x. There are 76 assets (95.4% of total balance) with DSCR between 0.0x and 0.5x and 1 assets (4.6% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.9x.

There are 1 assets (0.5% of total balance) that have maturity dates between 2025/1 and 2025/6, 1 assets (3.3% of total balance) that have maturity dates between 2026/7 and 2026/12, 29 assets (51.9% of total balance) that have maturity dates between 2029/7 and 2029/12, 44 assets (40.5% of total balance) that have maturity dates between 2030/1 and 2030/6, 1 assets (0.7% of total balance) that have maturity dates between 2031/7 and 2031/12 and 1 assets (3.1% of total balance) that have maturity dates between 2034/7 and 2034/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
