## **Transaction Summary**

The transaction closed on Feb 14 2017 and matures in Nov 2031. The pool's current aggregate principal balance is \$1305.5 million compared to \$1328.2 million at close.

The largest loan of the pool (7.7%) is secured by 229 West 43rd Street Retail Condo located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included BOWLMOR TIMES SQUARE (31.21%) and TIMES SQUARE ATTRACT (23.80%). The second largest loan of the pool (6.7%) is secured by 1384 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 93%. The major tenants included RADIOSURGERY (4.92%) and STAR RIDE KIDS (4.43%). The third largest loan of the pool (5.7%) is secured by 85 Tenth Avenue -Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Google (28.45%) and GSA (28.15%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.57% and 47 months as of 10/10/2020, respectively. There are a total of 52 loans and 59 properties in the portfolio. The appraisal LTV was approximately 56.8% compared to the Original loan to value (LTV), which was approximately 57.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.08x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.





# Occupancy Distribution (%)




#### Local Distribution



Among assets in the portfolio, there are 7 properties (32% of total balance) located in New York, 10 properties (20% of total balance) in California, 2 properties (6% of total balance) in Illinois, 1 property (5% of total balance) in Hawaii, 1 property (4% of total balance) in Kansas, 4 properties (4% of total balance) in Colorado, 1 property (3% of total balance) in Nevada and 1 property (3% of total balance) in Wisconsin. 



Most recent net operating income debt yield ranged from 2% to 23% with a weighted average NOI debt yield of 10.8%. NOI debt yield ranged from 2% to 23%. There were 1 assets (8% of total balance) with NOI debt yield between 2% and 4%, 7 assets (16% of total balance) with NOI debt yield between 6% and 8%, 11 assets (17% of total balance) with NOI debt yield between 8% and 10%, 16 assets (29% of total balance) with NOI debt yield between 10% and 12%, 9 assets (15% of total balance) with NOI debt yield between 12% and 14%, 3 assets (4% of total balance) with NOI debt yield between 14% and 16%, 3 assets (7% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%, 1 assets (5% of total balance) with NOI debt yield between 22% and 24%

There were 1 assets (7.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (13.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 27 assets (48.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (13.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (5.4% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.2% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (4.6% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (4.6% of total balance) with NCF DSCR between 4.0x and 5.0x. 



There are 4 assets (7.1% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (7.7% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (9.6% of total balance) with DSCR between 1.0x and 1.5x, 25 assets (41.1% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (17.1% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (5.8% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.2% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (5.7% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (4.6% of total balance) with DSCR between 5.5x and 6.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
