Transaction Summary

The transaction closed on Aug 15 2017 and matures in Aug 2027. The pool's current aggregate principal balance is \$901.5 million compared to \$932.4 million at close.

The largest loan of the pool (11.1%) is secured by General Motors Building - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 89%. The major tenants included Weil, Gotshal & Manges (24.62%) and Aramis (15.07%). The second largest loan of the pool (6.7%) is secured by Olympic Tower - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included NBA Properties, Inc. (36.54%) and Richemont North America, Inc. (24.06%). The third largest loan of the pool (6.0%) is secured by AHIP Northeast Portfolio IV located in New York-Jersey City-White Plains, NY-NJ-24.62% metropolitan area. Occupancy at the subject was 65%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.20% and 57 months as of 03/15/2022, respectively. There are a total of 48 loans and 134 properties in the portfolio. The appraisal LTV was approximately 53.2% compared to the Original loan to value (LTV), which was approximately 54.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.06x. As of 03/15/2022, 8.13% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from -4% to 59% with a weighted average NOI debt yield of 10.9%. NOI debt yield ranged from -4% to 59%. There were 1 assets (2% of total balance) with NOI debt yield between -4% and -2%, 2 assets (5% of total balance) with NOI debt yield between 4% and 6%, 3 assets (10% of total balance) with NOI debt vield between 6% and 8%. 11 assets (20% of total balance) with NOI debt yield between 8% and 10%, 18 assets (41% of total balance) with NOI debt yield between 10% and 12%, 6 assets (11% of total balance) with NOI debt yield between 12% and 14%, 3 assets (5% of total balance) with NOI debt yield between 14% and 16%, 1 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24% and 1 assets (1% of total balance) with NOI debt yield between 58% and 60%.

There were 1 assets (2.0% of total balance) with NCF DSCR between -0.5x and 0.0x, 2 assets (4.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (17.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (27.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (13.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (18.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (15.9% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.3% of total balance) with NCF DSCR between 4.0x and 4.5x. 



DSCRs ranged from -0.5x to 4.5x. There are 1 assets (2.0% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (4.9% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (13.7% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (22.4% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (18.4% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (21.8% of total balance) with DSCR between 2.5x and 3.0x. 3 assets (15.0% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.3% of total balance) with DSCR between 4.0x and 4.5x. There are 2 assets (73.3% of total balance) that have maturity dates between 2022/7 and 2022/12, 1 assets (6.2% of total balance) that have maturity dates between 2026/1 and 2026/6, 1 assets (18.7% of total balance) that have maturity dates between 2026/7 and 2026/12, 23 assets (460.6% of total balance) that have maturity dates between 2027/1 and 2027/6 and 21 assets (342.7% of total balance) that have maturity dates between 2027/7 and 2027/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
