# **Transaction Summary**

The transaction closed on Aug 24 2018 and matures in Aug 2028. The pool's current aggregate principal balance is \$713.1 million compared to \$717.6 million at close.

The largest loan of the pool (8.4%) is secured by Aventura Mall - Trust located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 91%. The major tenants included J. C. Penney Co. (15.91%) and AMC Theatres (6.47%). The second largest loan of the pool (7.1%) is secured by Bank of America Center located in metropolitan area. Occupancy at the subject was 88%. The major tenants included Commonwealth of Virginia (16.84%) and Bank Of America (15.79%). The third largest loan of the pool (5.9%) is secured by Westside NYC Multifamily Portfolio - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.88% and 27 months as of 10/15/2020, respectively. There are a total of 42 loans and 72 properties in the portfolio. The appraisal LTV was approximately 54.6% compared to the Original loan to value (LTV), which was approximately 57.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





# Occupancy Distribution (%)




#### Local Distribution



Among assets in the portfolio, there are 20 properties (20% of total balance) located in New York, 4 properties (14% of total balance) in Florida, 9 properties (11% of total balance) in Michigan, 2 properties (10% of total balance) in Virginia, 2 properties (8% of total balance) in New Jersey, 6 properties (6% of total balance) in Texas, 2 properties (5% of total balance) in Pennsylvania and 1 property (4% of total balance) in Washington. 



Most recent net operating income debt yield ranged from 4% to 23% with a weighted average NOI debt yield of 10.6%. NOI debt yield ranged from 4% to 23%. There were 1 assets (4% of total balance) with NOI debt yield between 4% and 6%, 6 assets (10% of total balance) with NOI debt yield between 6% and 8%, 12 assets (32% of total balance) with NOI debt yield between 8% and 10%, 13 assets (36% of total balance) with NOI debt yield between 10% and 12%, 3 assets (9% of total balance) with NOI debt yield between 12% and 14%, 2 assets (2% of total balance) with NOI debt yield between 14% and 16%, 2 assets (2% of total balance) with NOI debt yield between 16% and 18%, 2 assets (5% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24%

NCF DSCR ranged from 0.0x to 3.0x. There were 1 assets (1.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 13 assets (26.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (37.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (26.6% of total balance) with NCF DSCR between 2.0x and 2.5x and 4 assets (8.5% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.8x.







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology fo Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.
- 4). Do not address whether the market value of the security will remain stable over time.
- 5). Are not exact measures of the probability of default but are instead expressions of the relative credit risk of issuers and debt instruments.
