Transaction Summary

The transaction closed on Aug 24 2018 and matures in Aug 2028. The pool's current aggregate principal balance is \$712.6 million compared to \$717.6 million at close.

The largest loan of the pool (8.4%) is secured by Aventura Mall - Trust located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 91%. The major tenants included J. C. Penney Co. (15.91%) and AMC Theatres (6.47%). The second largest loan of the pool (7.1%) is secured by Bank of America Center located in metropolitan area. Occupancy at the subject was 88%. The major tenants included Commonwealth of Virginia (16.84%) and Bank Of America (15.79%). The third largest loan of the pool (5.9%) is secured by Westside NYC Multifamily Portfolio - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.88% and 29 months as of 12/15/2020, respectively. There are a total of 42 loans and 72 properties in the portfolio. The appraisal LTV was approximately 54.6% compared to the Original loan to value (LTV), which was approximately 57.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



Type Concentration







Among assets in the portfolio, there are 20 properties (20% of total balance) located in New York, 4 properties (14% of total balance) in Florida, 9 properties (11% of total balance) in Michigan, 2 properties (10% of total balance) in Virginia, 2 properties (8% of total balance) in New Jersey, 6 properties (6% of total balance) in Texas, 2 properties (5% of total balance) in Pennsylvania and 1 property (4% of total balance) in Washington. 




Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 10.7%. NOI debt yield ranged from 4% to 25%. There were 1 assets (4% of total balance) with NOI debt yield between 4% and 6%, 6 assets (10% of total balance) with NOI debt yield between 6% and 8%, 12 assets (32% of total balance) with NOI debt yield between 8% and 10%, 13 assets (36% of total balance) with NOI debt yield between 10% and 12%, 3 assets (9% of total balance) with NOI debt yield between 12% and 14%, 2 assets (2% of total balance) with NOI debt yield between 14% and 16%, 2 assets (2% of total balance) with NOI debt yield between 16% and 18%, 2 assets (4% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 24% and 26%

There were 1 assets (1.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 13 assets (26.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (37.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (26.6% of total balance) with NCF DSCR between 2.0x and 2.5x and 4 assets (8.5% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.8x.



DSCR (Current / Underwritten)



DSCRs ranged from 0.0x to 3.0x. There are 1 assets (1.3% of total balance) with DSCR between 0.0x and 0.5x, 8 assets (20.7% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (32.9% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (27.4% of total balance) with DSCR between 2.0x and 2.5x and 6 assets (17.7% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.9x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
