Transaction Summary

The transaction closed on Aug 24 2018 and matures in Aug 2028. The pool's current aggregate principal balance is \$707.5 million compared to \$717.6 million at close.

The largest loan of the pool (8.5%) is secured by Aventura Mall - Trust located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 89%. The major tenants included J. C. Penney Co. (15.91%) and AMC Theatres (6.47%). The second largest loan of the pool (7.1%) is secured by Bank of America Center located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Commonwealth of VA (17.53%) and Bank Of America (15.79%). The third largest loan of the pool (5.9%) is secured by Westside NYC Multifamily Portfolio - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.88% and 45 months as of 04/15/2022, respectively. There are a total of 42 loans and 72 properties in the portfolio. The appraisal LTV was approximately 64.8% compared to the Original loan to value (LTV), which was approximately 57.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





Occupancy Distribution (%)






Local Distribution



Most recent net operating income debt yield ranged from -2% to 25% with a weighted average NOI debt yield of 10.8%. NOI debt yield ranged from -2% to 25%. There were 1 assets (0.8% of total balance) with NCF DSCR between -0.5x and 0.0x, 1 assets (1.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 10 assets (18.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (52.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (12.5% of total balance) with NCF DSCR between 2.0x and 2.5x and 7 assets (14.8% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.9x.




DSCR (Current / Underwritten)



DSCRs ranged from -0.5x to 3.5x.There are 1 assets (0.8% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (1.3% of total balance) with DSCR between 0.0x and 0.5x, 8 assets (15.0% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (46.0% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (18.6% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (17.1% of total balance) with DSCR between 2.5x and 3.0x and 2 assets (1.2% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
