Transaction Summary

The transaction closed on Aug 22 2019 and matures in Jun 2034. The pool's current aggregate principal balance is \$809.6 million compared to \$811.1 million at close.

The largest loan of the pool (9.3%) is secured by 888 Figueroa located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 85%. The major tenants included NBC OPERATING (24.36%) and United States Government (5.20%). The second largest loan of the pool (8.6%) is secured by Woodlands Mall - Trust located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Forever 21 (11.23%) and Dick's Sporting Goods (10.96%). The third largest loan of the pool (8.6%) is secured by Hilton Penn's Landing located in Philadelphia, PA metropolitan area. Occupancy at the subject was 86%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.27% and 15 months as of 10/15/2020, respectively. There are a total of 33 loans and 58 properties in the portfolio. The appraisal LTV was approximately 55.8% compared to the Original loan to value (LTV), which was approximately 55.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.08x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.






Local Distribution





Most recent net operating income debt yield ranged from 2% to 17% with a weighted average NOI debt yield of 9.1%. NOI debt yield ranged from 2% to 17%. There were 4 assets (15% of total balance) with NOI debt yield between 2% and 4%, 3 assets (7% of total balance) with NOI debt yield between 4% and 6%, 4 assets (12% of total balance) with NOI debt yield between 6% and 8%, 10 assets (26% of total balance) with NOI debt yield between 8% and 10%, 5 assets (11% of total balance) with NOI debt yield between 10% and 12%, 4 assets (16% of total balance) with NOI debt yield between 12% and 14%, 2 assets (12% of total balance) with NOI debt yield between 14% and 16% and 1 assets (1% of total balance) with NOI debt yield between 16% and 18%.

NCF DSCR ranged from 0.0x to 5.0x. There were 6 assets (16.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (13.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 3 assets (5.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 12 assets (26.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 3 assets (14.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (10.4% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (8.6% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.8% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (3.4% of total balance) with NCF DSCR between 4.5x and 5.0x. 
DSCR (Current / Underwritten)

Underwritten DSCR



DSCRs ranged from 0.0x to 5.0x.There are 6 assets (16.6% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (7.0% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (9.4% of total balance) with DSCR between 1.0x and 1.5x, 10 assets (21.1% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (14.1% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (19.1% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (9.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (3.4% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
