Transaction Summary

The transaction closed on Oct 17 2019 and matures in Oct 2029. The pool's current aggregate principal balance is \$799.9 million compared to \$809.3 million at close.

The largest loan of the pool (8.5%) is secured by GNL Office and Industrial Portfolio located in Los Angeles-Long Beach-Glendale, CA-27.38% Detroit-Dearborn-Livonia, MI-5.25% metropolitan area. Occupancy at the subject was 100%. The major tenants included AT&T (18.29%) and Hanes Co (12.55%). The second largest loan of the pool (5.3%) is secured by Uline Arena located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 94%. The major tenants included Recreational Equipment (20.60%) and RGN National Business Center (17.59%). The third largest loan of the pool (4.8%) is secured by Ocean Edge Resort & Golf Club located in metropolitan area. Occupancy at the subject was 32%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.02% and 30 months as of 03/15/2022, respectively. There are a total of 48 loans and 129 properties in the portfolio. The appraisal LTV was approximately 56.5% compared to the Original loan to value (LTV), which was approximately 56.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.84x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.





Occupancy Distribution (%)




Local Distribution



Among assets in the portfolio, there are 8 properties (15% of total balance) located in New York, 8 properties (11% of total balance) in California, 5 properties (9% of total balance) in New Jersey, 5 properties (9% of total balance) in Florida, 11 properties (8% of total balance) in Texas, 5 properties (7% of total balance) in Massachusetts and 1 property (5% of total balance) in Washington DC. 



Most recent net operating income debt yield ranged from 2% to 27% with a weighted average NOI debt yield of 8.7%. NOI debt yield ranged from 2% to 27%. There were 2 assets (5% of total balance) with NOI debt yield between 2% and 4%, 6 assets (14% of total balance) with NOI debt yield between 4% and 6%, 8 assets (16% of total balance) with NOI debt yield between 6% and 8%, 18 assets (40% of total balance) with NOI debt yield between 8% and 10%, 10 assets (21% of total balance) with NOI debt yield between 10% and 12%, 2 assets (1% of total balance) with NOI debt yield between 12% and 14%, 1 assets (3% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%

There were 2 assets (4.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (6.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 4 assets (11.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 23 assets (38.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (25.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (9.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (2.7% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.8% of total balance) with NCF DSCR between 4.0x and 4.5x. 



There are 1 assets (1.2% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (4.4% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (11.6% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (40.3% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (17.3% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (21.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.7% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.8% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
