# **Transaction Summary**

The transaction closed on Dec 20 2019 and matures in Dec 2029. The pool's current aggregate principal balance is \$786.8 million compared to \$789.2 million at close.

The largest loan of the pool (7.7%) is secured by Parklawn Building located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 73%. The largest tenant was United States Government (72.87%). The second largest loan of the pool (6.4%) is secured by Century Plaza Towers - Trust located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 93%. The major tenants included Bank of America (5.19%) and Manatt Phelps (4.85%). The third largest loan of the pool (6.4%) is secured by Meridian Pointe Apartments located in Tacoma-Lakewood, WA metropolitan area. Occupancy at the subject was 98%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.63% and 13 months as of 12/15/2020, respectively. There are a total of 48 loans and 67 properties in the portfolio. The appraisal LTV was approximately 54.5% compared to the Original loan to value (LTV), which was approximately 54.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.16x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.








### Local Distribution







There are 33 assets (60.8% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (8.4% of total balance) with DSCR between 0.5x and 1.0x, 3 assets (8.7% of total balance) with DSCR between 1.0x and 1.5x, 1 assets (1.0% of total balance) with DSCR between 1.5x and 2.0x, 2 assets (4.7% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (7.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.1% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (2.3% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (1.0% of total balance) with DSCR between 6.5x and 7.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
