## Transaction Summary

The transaction closed on Jan 28 2016 and matures in Jan 2026. The pool's current aggregate principal balance is \$676.6 million compared to \$704.0 million at close.

The largest loan of the pool (8.2%) is secured by Element LA located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Riot Games Inc (100.00%). The second largest loan of the pool (7.2%) is secured by 123 Townsend located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 73%. The major tenants included PayPal (44.21%) and Reflektive inc (16.65%). The third largest loan of the pool (7.2%) is secured by Empire Mall located in metropolitan area. Occupancy at the subject was 78%. The major tenants included JC Penney (11.94%) and Macy's (8.96%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.79% and 58 months as of 10/10/2020, respectively. There are a total of 38 loans and 67 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 62.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.01x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

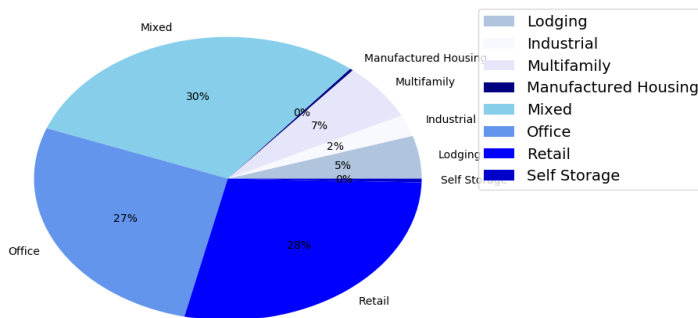

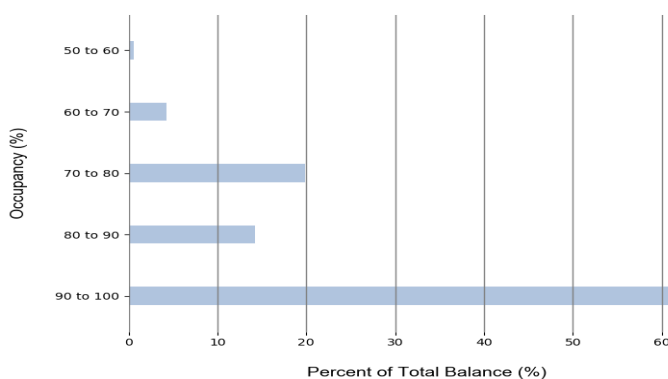

Occupancy Distribution (%)

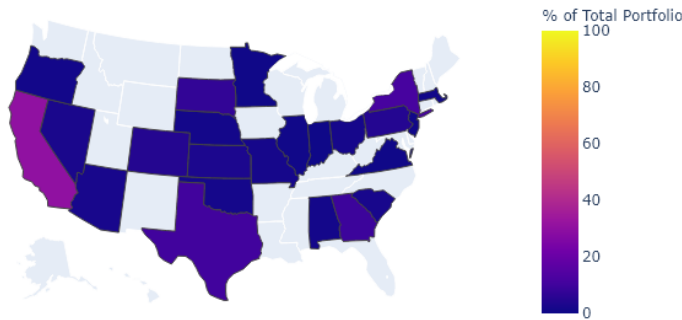

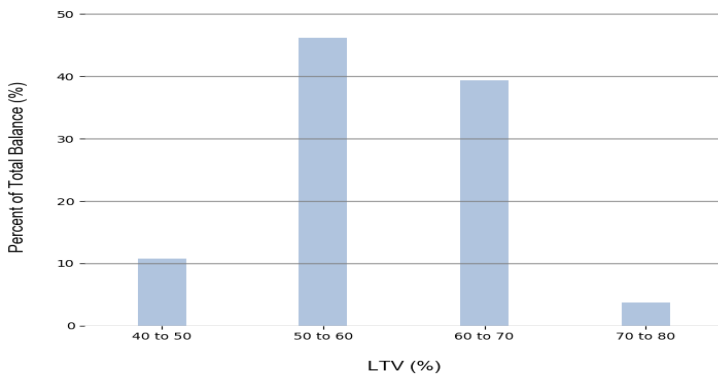
Local Distribution

LTV Distribution (%)



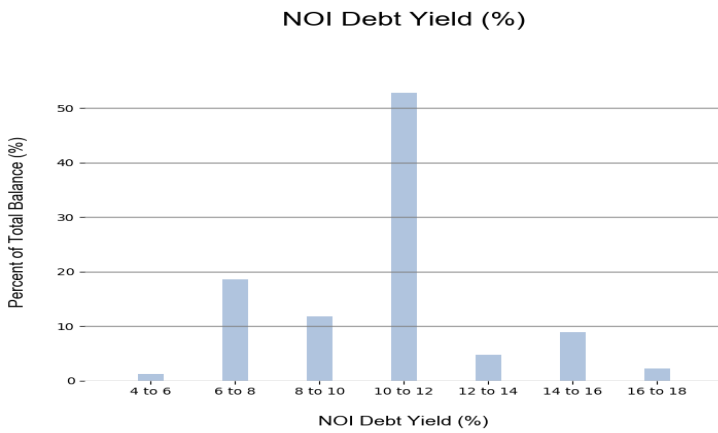

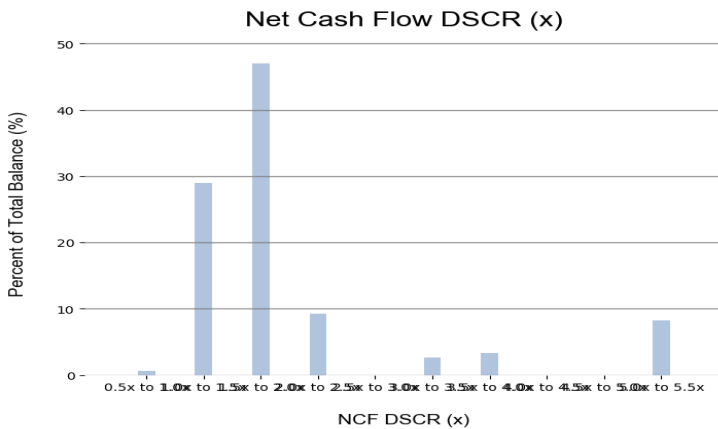

Most recent net operating income debt yield ranged from 4% to 17% with a weighted average NOI debt yield of 10.5%. NOI debt yield ranged from 4% to 17%. There were 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 6 assets (19% of total balance) with NOI debt yield between 6% and 8%, 7 assets (12% of total balance) with NOI debt yield between 8% and 10%, 14 assets (53% of total balance) with NOI debt yield between 10% and 12%, 3 assets (5% of total balance) with NOI debt yield between 12% and 14%, 6 assets (9% of total balance) with NOI debt yield between 14% and 16% and 1 assets (2% of total balance) with NOI debt yield between 16% and 18%.

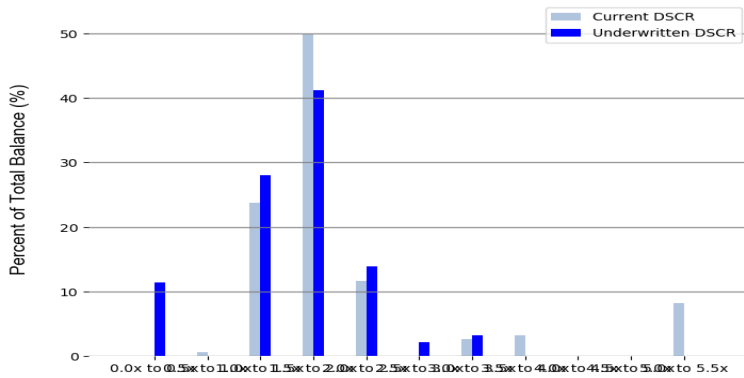

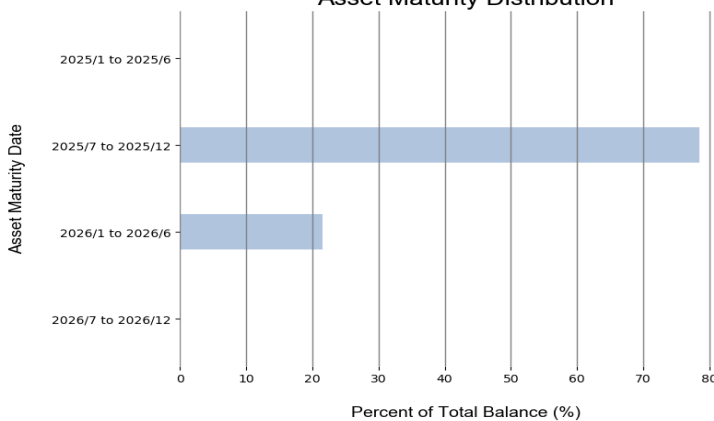
**DSCR Distribution (x)**

There are 1 assets (0.6% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (23.8% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (49.8% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (11.7% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (2.6% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (3.3% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (8.2% of total balance) with DSCR between 5.0x and 5.5x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
