## **Transaction Summary**

The transaction closed on Jan 28 2016 and matures in Jan 2026. The pool's current aggregate principal balance is \$659.7 million compared to \$697.5 million at close.

The largest loan of the pool (8.4%) is secured by Element LA located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Riot Games Inc (100.00%). The second largest loan of the pool (7.2%) is secured by 123 Townsend located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 73%. The major tenants included PayPal (44.21%) and Reflektive inc (16.65%). The third largest loan of the pool (7.2%) is secured by Empire Mall located in metropolitan area. Occupancy at the subject was 76%. The major tenants included JC Penney (11.94%) and Macy's (8.96%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.79% and 75 months as of 03/10/2022, respectively. There are a total of 37 loans and 66 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 62.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.06x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





#### Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from -8% to 17% with a weighted average NOI debt yield of 9.6%. NOI debt yield ranged from -8% to 17%. There were 1 assets (3% of total balance) with NOI debt yield between -8% and -6%, 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 8 assets (21% of total balance) with NOI debt yield between 6% and 8%, 8 assets (34% of total balance) with NOI debt yield between 8% and 10%, 7 assets (15% of total balance) with NOI debt yield between 10% and 12%, 6 assets (19% of total balance) with NOI debt yield between 12% and 14%, 3 assets (3% of total balance) with NOI debt yield between 14% and 16%, 3 assets (4% of total balance) with NOI debt yield between 16% and 18%





DSCRs ranged from -1.0x to 5.5x.There are 1 assets (3.1% of total balance) with DSCR between -1.0x and -0.5x, 1 assets (0.6% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (7.7% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (28.7% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (26.5% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (10.2% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (6.1% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.7% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (6.1% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (8.4% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 2.2x.

There are 29 assets (529.7% of total balance) that have maturity dates between 2025/7 and 2025/12 and 8 assets (129.9% of total balance) that have maturity dates between 2026/1 and 2026/6.

## Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
