Transaction Summary

The transaction closed on May 18 2016 and matures in May 2046. The pool's current aggregate principal balance is \$797.3 million compared to \$834.1 million at close.

The largest loan of the pool (8.8%) is secured by OZRE Leased Fee Portfolio located in Montgomery County-Bucks County-Chester County, PA-17.37% Camden, NJ-15.55% Washington-Arlington-Alexandria, DC-VA-MD-WV-6.29% metropolitan area. Occupancy at the subject was 100%. The major tenants included PPD (5.26%) and Paralion Holdings LLC (3.95%). The second largest loan of the pool (6.3%) is secured by Hyatt Regency St. Louis at The Arch located in metropolitan area. Occupancy at the subject was 66%. The third largest loan of the pool (5.6%) is secured by 215 West 34th Street & 218 West 35th Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included 34TH HOTEL VENTURES LLC (73.93%) and DSW Shoe (12.36%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.89% and 59 months as of 12/10/2020, respectively. There are a total of 49 loans and 152 properties in the portfolio. The appraisal LTV was approximately 63.5% compared to the Original loan to value (LTV), which was approximately 65.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 12/10/2020, 1.83% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution





There were 1 assets (1.1% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (1.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 16 assets (26.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (39.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (25.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (1.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (2.0% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (2.5% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (2.5% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.0x to 5.0x.There are 1 assets (1.1% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.7% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (23.3% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (34.4% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (34.2% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (1.9% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (4.5% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
