Transaction Summary

The transaction closed on Nov 22 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$757.5 million compared to \$781.8 million at close.

The largest loan of the pool (9.4%) is secured by Hill7 Office located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 100%. The major tenants included Redfin Corporation (36.19%) and HBO Code Labs Inc. (35.94%). The second largest loan of the pool (9.2%) is secured by Vertex Pharmaceuticals HQ located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The major tenants included Vertex Pharmaceuticals Inc. (95.47%) and Bright Horizons Centers (1.12%). The third largest loan of the pool (9.2%) is secured by Potomac Mills - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 95%. The major tenants included Costco Warehouse (10.15%) and J.C. Penney (6.86%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.24% and 49 months as of 10/10/2020, respectively. There are a total of 44 loans and 119 properties in the portfolio. The appraisal LTV was approximately 55.2% compared to the Original loan to value (LTV), which was approximately 56.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.54x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.





Occupancy Distribution (%)




Local Distribution




NOI Debt Yield (%)

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 6.0x. There were 14 assets (22.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 23 assets (41.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 3 assets (7.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (1.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (9.4% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (9.2% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (9.2% of total balance) with NCF DSCR between 6.0x and 6.5x. 



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
