## Transaction Summary

The transaction closed on Nov 22 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$756.4 million compared to \$781.8 million at close.

The largest loan of the pool (9.4%) is secured by Hill7 Office located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 100%. The major tenants included Redfin Corporation (36.19%) and HBO Code Labs Inc. (35.94%). The second largest loan of the pool (9.3%) is secured by Vertex Pharmaceuticals HQ located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The major tenants included Vertex Pharmaceuticals Inc. (95.47%) and Bright Horizons Centers (1.12%). The third largest loan of the pool (9.3%) is secured by Potomac Mills - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 95%. The major tenants included Costco Warehouse (10.15%) and J.C. Penney (6.86%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.24% and 51 months as of 12/10/2020, respectively. There are a total of 44 loans and 119 properties in the portfolio. The appraisal LTV was approximately 56.4% compared to the Original loan to value (LTV), which was approximately 56.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.54x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.

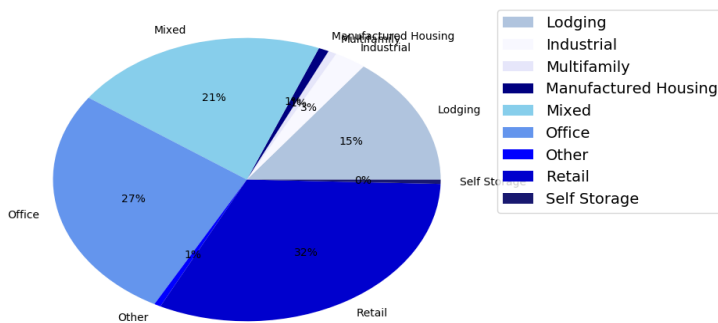

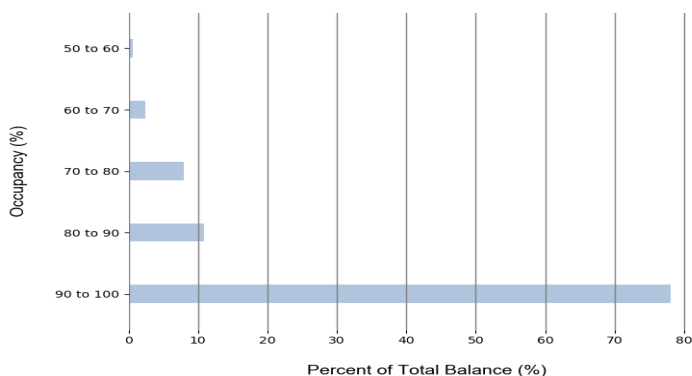

Occupancy Distribution (%)

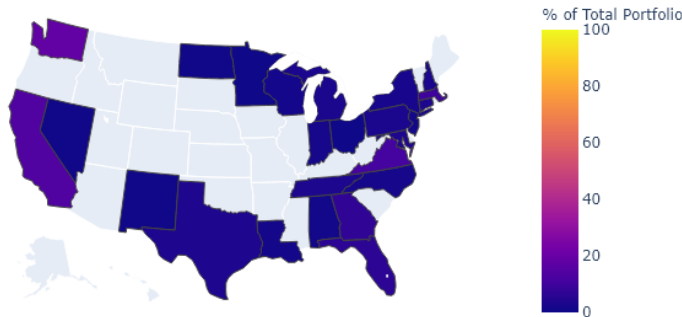

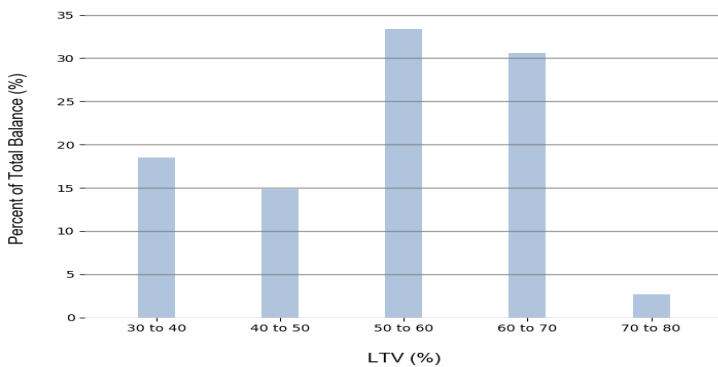
Local Distribution

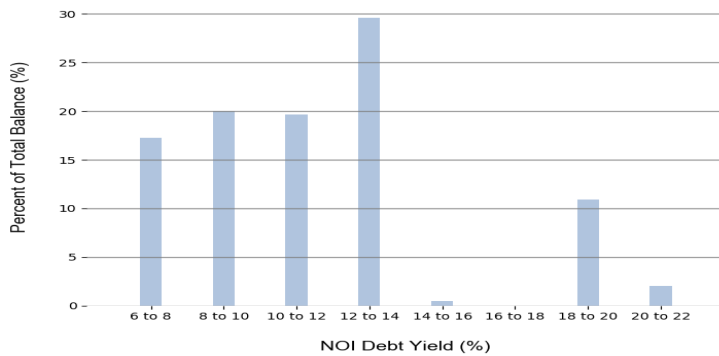

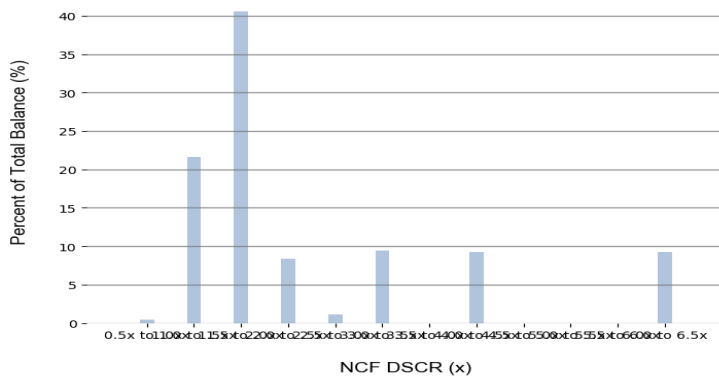
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

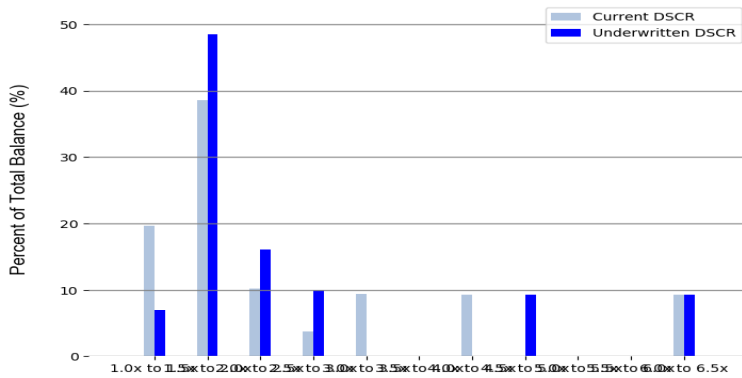

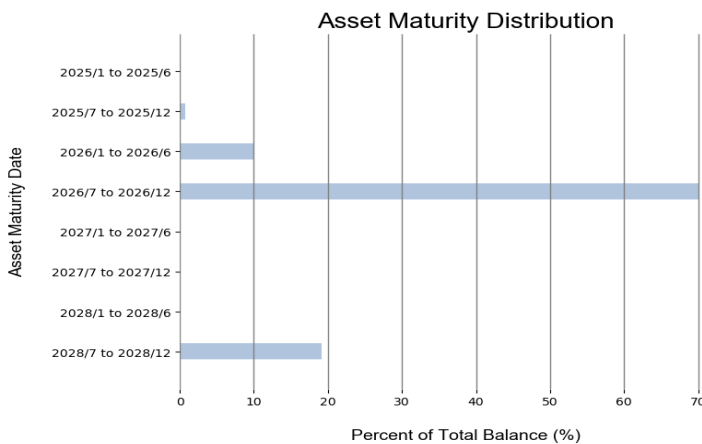

There are 10 assets (19.7% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (38.6% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (10.2% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (3.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (9.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (9.3% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (9.3% of total balance) with DSCR between 6.0x and 6.5x. The most recent weighted average DSCR is 2.6x.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
