Transaction Summary

The transaction closed on Nov 22 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$736.6 million compared to \$770.6 million at close.

The largest loan of the pool (9.6%) is secured by Hill7 Office located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 99%. The major tenants included Redfin Corporation (36.19%) and HBO Code Labs Inc. (35.94%). The second largest loan of the pool (9.5%) is secured by Vertex Pharmaceuticals HQ located in Boston, MA metropolitan area. Occupancy at the subject was 99%. The major tenants included Vertex Pharmaceuticals Inc. (95.47%) and Bright Horizons Centers (1.12%). The third largest loan of the pool (9.5%) is secured by Potomac Mills - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 89%. The major tenants included Costco Warehouse (10.15%) and J.C. Penney (6.86%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.23% and 67 months as of 04/10/2022, respectively. There are a total of 43 loans and 118 properties in the portfolio. The appraisal LTV was approximately 55.5% compared to the Original loan to value (LTV), which was approximately 55.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.30x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.








Local Distribution





Most recent net operating income debt yield ranged from -4% to 21% with a weighted average NOI debt yield of 10.4%. NOI debt yield ranged from -4% to 21%. 



DSCRs ranged from -0.5x to 6.5x. There are 1 assets (0.7% of total balance) with DSCR between -0.5x and 0.0x, 3 assets (6.5% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (13.1% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (9.7% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (26.4% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (10.8% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (4.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (9.6% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (9.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (9.5% of total balance) with DSCR between 6.0x and 6.5x. There are 1 assets (4.9% of total balance) that have maturity dates between 2025/7 and 2025/12, 6 assets (74.2% of total balance) that have maturity dates between 2026/1 and 2026/6, 33 assets (512.4% of total balance) that have maturity dates between 2026/7 and 2026/12 and 3 assets (145.0% of total balance) that have maturity dates between 2028/7 and 2028/12.



Sensitivity Analysis

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.
