Transaction Summary

The transaction closed on Dec 21 2016 and matures in Dec 2031. The pool's current aggregate principal balance is \$630.6 million compared to \$645.5 million at close.

The largest loan of the pool (9.0%) is secured by Hilton Hawaiian Village - Trust located in metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (8.3%) is secured by 25 Senate Place Jersey City located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The third largest loan of the pool (7.9%) is secured by Google Kirkland Campus Phase II located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Google (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.46% and 49 months as of 12/10/2020, respectively. There are a total of 36 loans and 63 properties in the portfolio. The appraisal LTV was approximately 91.5% compared to the Original loan to value (LTV), which was approximately 54.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.23x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.






Local Distribution





Most recent net operating income debt yield ranged from 2% to 23% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 2% to 23%. There were 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 3 assets (13% of total balance) with NOI debt yield between 6% and 8%, 10 assets (43% of total balance) with NOI debt yield between 8% and 10%, 12 assets (21% of total balance) with NOI debt yield between 10% and 12%, 6 assets (10% of total balance) with NOI debt yield between 12% and 14%, 2 assets (1% of total balance) with NOI debt yield between 14% and 16%, 1 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (9% of total balance) with NOI debt yield between 22% and 24%





There are 1 assets (1.0% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.8% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (22.4% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (23.2% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (21.4% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (15.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (6.4% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (9.0% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
