Transaction Summary

The transaction closed on Jun 08 2017 and matures in May 2032. The pool's current aggregate principal balance is \$542.4 million compared to \$564.9 million at close.

The largest loan of the pool (10.1%) is secured by Ohio Valley Plaza located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Walmart (30.51%) and Lowe's Home Improvement (19.84%). The second largest loan of the pool (8.1%) is secured by Pershing Square Building located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 76%. The major tenants included Pershing Hill LLC Perch (9.76%) and Instride/Attainment Holdco (7.56%). The third largest loan of the pool (7.2%) is secured by Crossings at Hobart located in Gary, IN metropolitan area. Occupancy at the subject was 87%. The major tenants included Walmart (26.72%) and Hobby Lobby (7.77%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.97% and 60 months as of 04/15/2022, respectively. There are a total of 37 loans and 56 properties in the portfolio. The appraisal LTV was approximately 58.0% compared to the Original loan to value (LTV), which was approximately 59.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.57x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 21% with a weighted average NOI debt yield of 10.2%. NOI debt yield ranged from 0% to 21%. There were 3 assets (6% of total balance) with NOI debt yield between 0% and 2%, 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 2 assets (4% of total balance) with NOI debt yield between 6% and 8%, 11 assets (46% of total balance) with NOI debt yield between 8% and 10%, 8 assets (17% of total balance) with NOI debt yield between 10% and 12%, 4 assets (14% of total balance) with NOI debt yield between 12% and 14%, 2 assets (4% of total balance) with NOI debt yield between 14% and 16%, 4 assets (5% of total balance) with NOI debt yield between 18% and 20%, 2 assets (2% of total balance) with NOI debt yield between 20% and 22%

There were 3 assets (6.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (7.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (27.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (40.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (14.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (4.1% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.6x.







DSCRs ranged from 0.0x to 4.0x.There are 3 assets (6.0% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (3.0% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (24.1% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (39.8% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (11.3% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (15.1% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.7x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
