Transaction Summary

The transaction closed on Nov 07 2013 and matures in Oct 2033. The pool's current aggregate principal balance is \$928.1 million compared to \$1038.4 million at close.

The largest loan of the pool (14.8%) is secured by 175 West Jackson located in metropolitan area. Occupancy at the subject was 65%. The major tenants included Enova International Inc t0023209 (11.58%) and Wolverine Trading LP (6.06%). The second largest loan of the pool (14.8%) is secured by Miracle Mile Shops located in metropolitan area. Occupancy at the subject was 90%. The major tenants included V Theater (8.56%) and Victoria's Secret (4.65%). The third largest loan of the pool (6.7%) is secured by Westlakes located in Montgomery County-Bucks County-Chester County, PA metropolitan area. Occupancy at the subject was 94%. The major tenants included Fox and Roach (8.34%) and Brinker Capital Inc (7.68%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.17% and 101 months as of 03/10/2022, respectively. There are a total of 50 loans and 81 properties in the portfolio. The appraisal LTV was approximately 80.4% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.34x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.

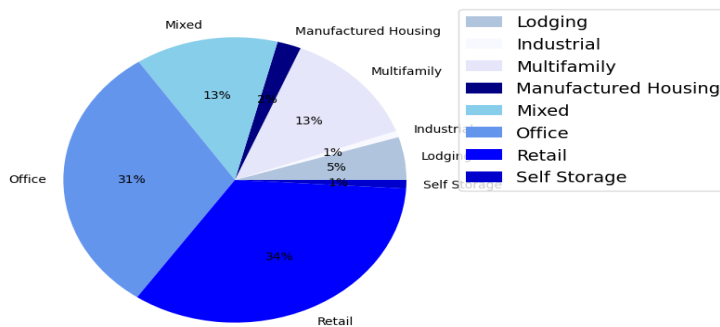

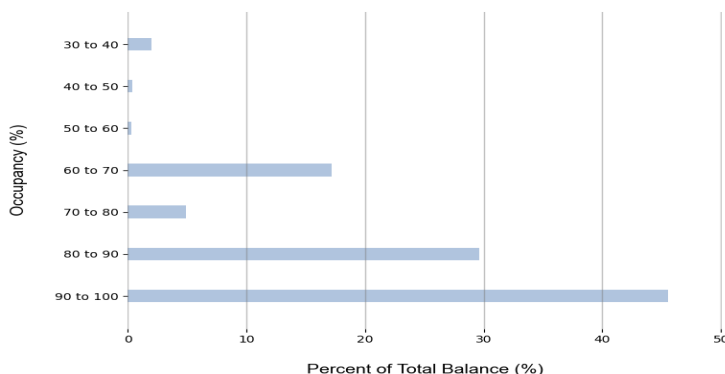

Occupancy Distribution (%)

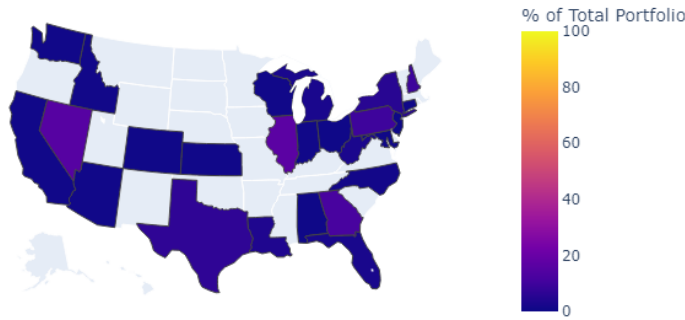

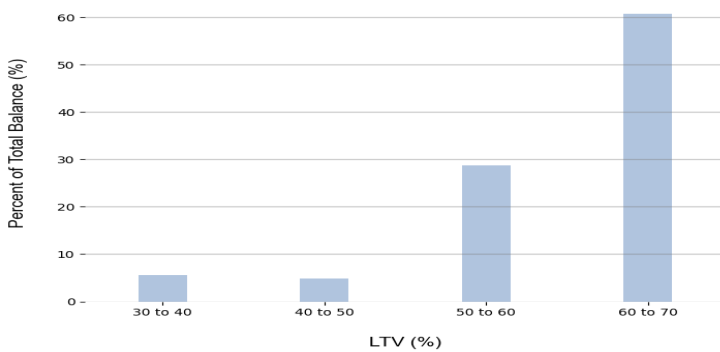
Local Distribution

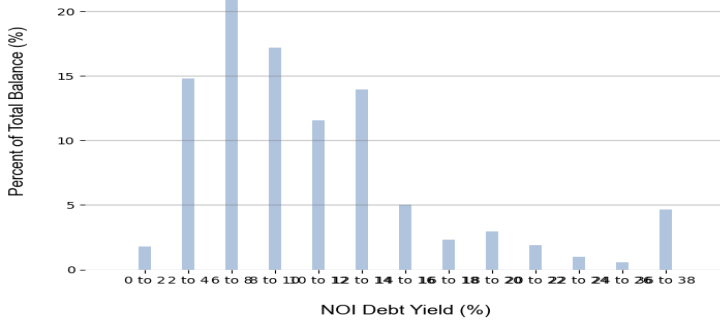

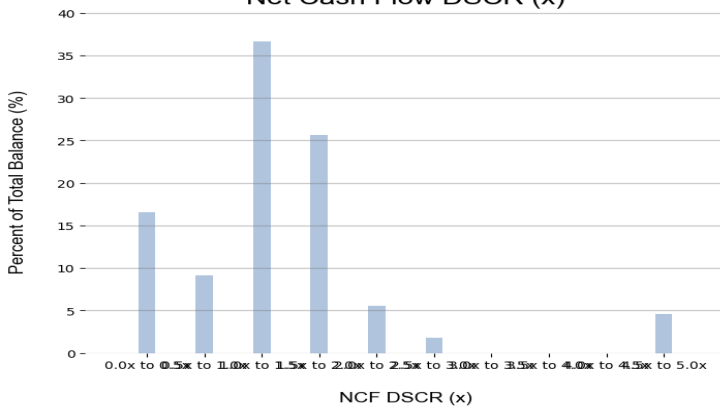
NOI Debt Yield (%)

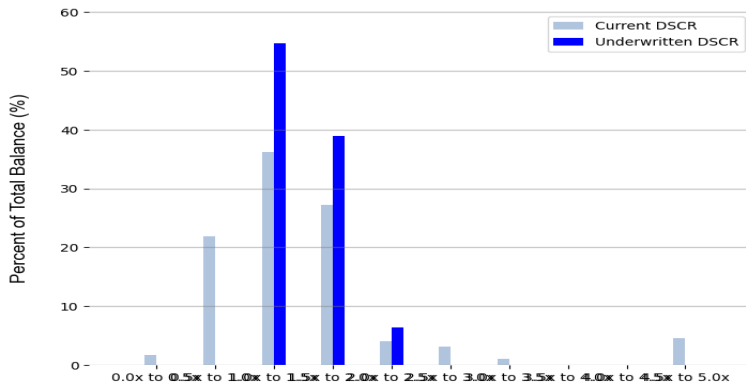

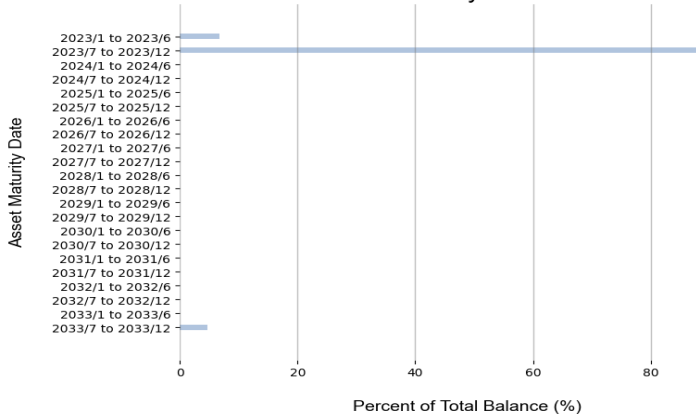
DSCR Distribution (x)

There are 2 assets (1.8% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (21.9% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (36.2% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (27.2% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (4.0% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (3.2% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.6% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


