### **Transaction Summary**

The transaction closed on Jan 22 2014 and matures in Nov 2043. The pool's current aggregate principal balance is \$1027.7 million compared to \$1098.9 million at close.

The largest loan of the pool (14.5%) is secured by Google and Amazon Office Portfolio located in metropolitan area. Occupancy at the subject was 99%. The largest tenant was Google (66.21%). The second largest loan of the pool (15.1%) is secured by 60 Hudson Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 74%. The major tenants included DATAGRYD DATA CENTERS LLC (15.72%) and MCI (14.38%). The third largest loan of the pool (10.7%) is secured by 625 Madison Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was SLG 625 Lessee LLC (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.66% and 84 months as of 12/10/2020, respectively. There are a total of 45 loans and 68 properties in the portfolio. The appraisal LTV was approximately 61.8% compared to the Original loan to value (LTV), which was approximately 58.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.16x. As of 12/10/2020, 10.69% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.



Type Concentration

















# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
