### **Transaction Summary**

The transaction closed on Jan 22 2014 and matures in Nov 2043. The pool's current aggregate principal balance is \$968.5 million compared to \$1053.5 million at close.

The largest loan of the pool (15.0%) is secured by Google and Amazon Office Portfolio located in metropolitan area. Occupancy at the subject was 99%. The largest tenant was Google (66.21%). The second largest loan of the pool (16.0%) is secured by 60 Hudson Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 73%. The major tenants included DATAGRYD DATA CENTERS LLC (15.72%) and MCI (14.38%). The third largest loan of the pool (11.3%) is secured by 625 Madison Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was SLG 625 Lessee LLC (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.64% and 100 months as of 04/10/2022, respectively. There are a total of 42 loans and 64 properties in the portfolio. The appraisal LTV was approximately 54.9% compared to the Original loan to value (LTV), which was approximately 56.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.50x. As of 04/10/2022, 11.33% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.



Type Concentration







## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
