## **Transaction Summary**

The transaction closed on Apr 09 2014 and matures in Apr 2024. The pool's current aggregate principal balance is \$841.6 million compared to \$912.9 million at close.

The largest loan of the pool (14.3%) is secured by 25 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included Leman Manhattan Preparatory (20.14%) and Teach for America (18.06%). The second largest loan of the pool (10.6%) is secured by iPark Norwalk located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Norwalk Hospital (30.67%) and LA Fitness (16.27%). The third largest loan of the pool (8.6%) is secured by Sanibel Harbour Marriott Resort & Spa located in metropolitan area. Occupancy at the subject was 59%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.96% and 81 months as of 12/10/2020, respectively. There are a total of 44 loans and 60 properties in the portfolio. The appraisal LTV was approximately 74.7% compared to the Original loan to value (LTV), which was approximately 67.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.71x. As of 12/10/2020, 0.68% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





#### Occupancy Distribution (%)




#### Local Distribution









# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
