Transaction Summary

The transaction closed on Apr 09 2014 and matures in Apr 2024. The pool's current aggregate principal balance is \$810.2 million compared to \$898.5 million at close.

The largest loan of the pool (14.8%) is secured by 25 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included Leman Manhattan Preparatory (20.14%) and Teach for America (18.06%). The second largest loan of the pool (10.7%) is secured by iPark Norwalk located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Norwalk Hospital (30.67%) and LA Fitness (16.27%). The third largest loan of the pool (8.5%) is secured by Sanibel Harbour Marriott Resort & Spa located in metropolitan area. Occupancy at the subject was 39%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.95% and 96 months as of 03/10/2022, respectively. There are a total of 42 loans and 49 properties in the portfolio. The appraisal LTV was approximately 84.0% compared to the Original loan to value (LTV), which was approximately 67.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.60x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.



Type Concentration















DSCR (Current / Underwritten)



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
