## **Transaction Summary**

The transaction closed on Apr 09 2014 and matures in Apr 2024. The pool's current aggregate principal balance is \$809.0 million compared to \$898.5 million at close.

The largest loan of the pool (14.8%) is secured by 25 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 82%. The major tenants included Leman Manhattan Preparatory (20.79%) and Teach for America (18.06%). The second largest loan of the pool (10.7%) is secured by iPark Norwalk located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Norwalk Hospital (30.67%) and LA Fitness (16.27%). The third largest loan of the pool (8.5%) is secured by Sanibel Harbour Marriott Resort & Spa located in metropolitan area. Occupancy at the subject was 62%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.95% and 97 months as of 04/10/2022, respectively. There are a total of 42 loans and 49 properties in the portfolio. The appraisal LTV was approximately 83.9% compared to the Original loan to value (LTV), which was approximately 67.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.60x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.






#### Local Distribution





Most recent net operating income debt yield ranged from 2% to 23% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 2% to 23%. There were 1 assets (3% of total balance) with NOI debt yield between 2% and 4%, 3 assets (1% of total balance) with NOI debt yield between 4% and 6%, 1 assets (2% of total balance) with NOI debt yield between 6% and 8%, 6 assets (27% of total balance) with NOI debt yield between 8% and 10%, 10 assets (45% of total balance) with NOI debt yield between 10% and 12%, 7 assets (10% of total balance) with NOI debt yield between 12% and 14%, 8 assets (8% of total balance) with NOI debt yield between 14% and 16%, 3 assets (2% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%, 1 assets (2% of total balance) with NOI debt yield between 20% and 22% and 1 assets (1% of total balance) with NOI debt yield between 22% and 24%.

There were 3 assets (3.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (19.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 10 assets (29.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 14 assets (17.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (21.2% of total balance) with NCF DSCR between 2.0x and 2.5x and 2 assets (9.6% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.6x.







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
