## **Transaction Summary**

The transaction closed on May 13 2014 and matures in May 2024. The pool's current aggregate principal balance is \$919.6 million compared to \$1007.5 million at close.

The largest loan of the pool (15.2%) is secured by Bronx Terminal Market located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included Target (20.51%) and BJ's Wholesale Club (14.16%). The second largest loan of the pool (14.1%) is secured by 25 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Leman Manhattan Preparatory School LLC (20.42%) and Teach for America (18.32%). The third largest loan of the pool (9.8%) is secured by Cottonwood Mall located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Dillard's (40.24%) and JC Penney (29.43%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.87% and 96 months as of 04/10/2022, respectively. There are a total of 48 loans and 64 properties in the portfolio. The appraisal LTV was approximately 61.2% compared to the Original loan to value (LTV), which was approximately 65.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.54x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





## Occupancy Distribution (%)




#### Local Distribution









# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
