Transaction Summary

The transaction closed on Aug 21 2014 and matures in Aug 2024. The pool's current aggregate principal balance is \$858.1 million compared to \$936.0 million at close.

The largest loan of the pool (8.1%) is secured by Bridgepoint Tower located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Bridgepoint Education (18.27%). The second largest loan of the pool (7.0%) is secured by The Shoppes at Webb Gin located in metropolitan area. Occupancy at the subject was 91%. The major tenants included Barnes & Noble (7.46%) and Sprouts Farmer's Market (7.38%). The third largest loan of the pool (6.3%) is secured by Cipriani Manhattan Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 69%. The major tenants included CIPRIANI USA INC (12.92%) and 42ND STREET DENTAL (3.56%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.73% and 74 months as of 10/10/2020, respectively. There are a total of 59 loans and 71 properties in the portfolio. The appraisal LTV was approximately 61.3% compared to the Original loan to value (LTV), which was approximately 65.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.10x. As of 10/10/2020, 1.09% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.





Occupancy Distribution (%)




Local Distribution









There are 1 assets (0.7% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.0% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (18.2% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (45.9% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (15.1% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (8.8% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.1% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (0.9% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (6.3% of total balance) with DSCR between 7.0x and 7.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
