## Transaction Summary

The transaction closed on Aug 21 2014 and matures in Aug 2024. The pool's current aggregate principal balance is \$799.1 million compared to \$898.7 million at close.

The largest loan of the pool (8.4%) is secured by Bridgepoint Tower located in metropolitan area. Occupancy at the subject was 10%. The largest tenant was Bridgepoint Education (9.06%). The second largest loan of the pool (7.3%) is secured by The Shoppes at Webb Gin located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Barnes & Noble (7.46%) and Sprouts Farmer's Market (7.38%). The third largest loan of the pool (6.6%) is secured by Cipriani Manhattan Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 69%. The major tenants included CIPRIANI USA INC (12.92%) and 42ND STREET DENTAL (3.56%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.72% and 92 months as of 04/10/2022, respectively. There are a total of 55 loans and 64 properties in the portfolio. The appraisal LTV was approximately 61.2% compared to the Original loan to value (LTV), which was approximately 64.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.01x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 72%.

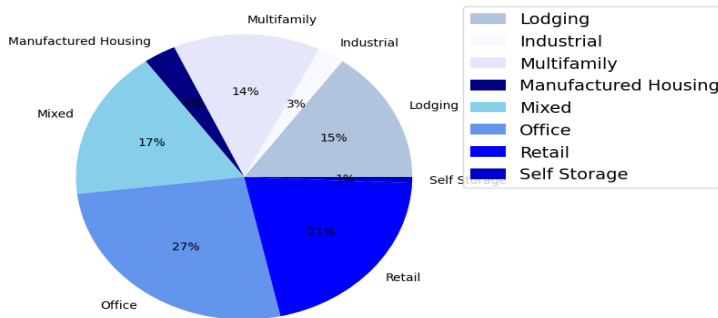

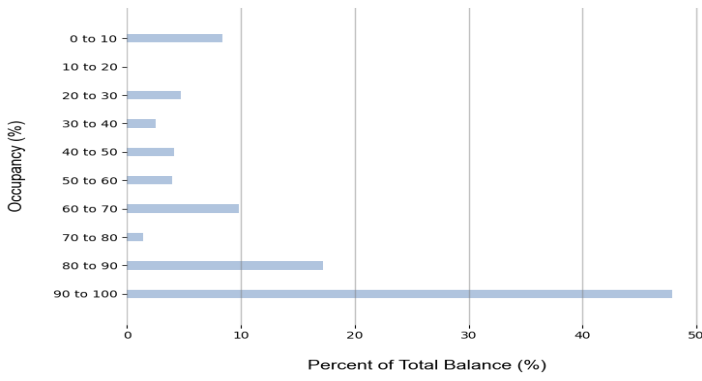

### Occupancy Distribution (%)

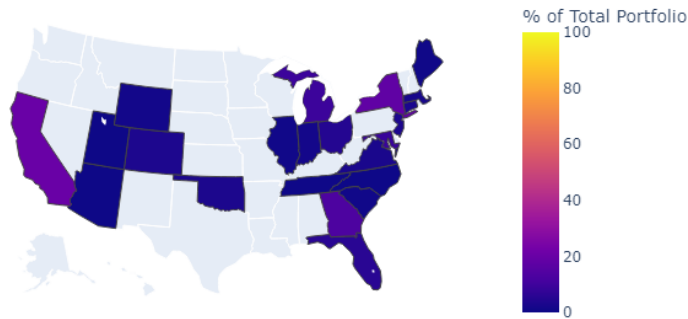

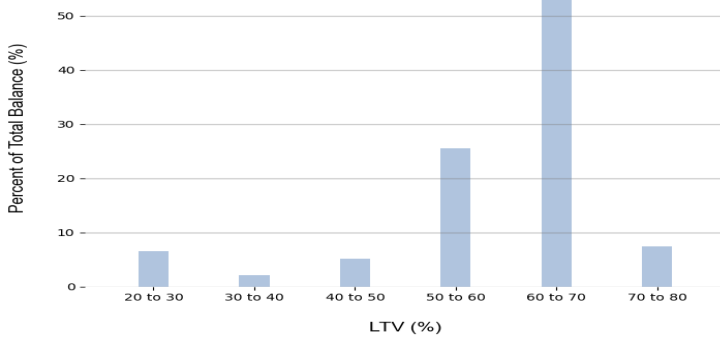
Local Distribution



Among assets in the portfolio, there are 10 properties (20% of total balance) located in California, 7 properties (18% of total balance) in New York, 4 properties (13% of total balance) in Georgia, 3 properties (9% of total balance) in Michigan, 6 properties (9% of total balance) in Maryland, 5 properties (6% of total balance) in Florida, 3 properties (4% of total balance) in Ohio and 1 property (3% of total balance) in Colorado. Other properties are located in the state of New Jersey, Oklahoma, Connecticut, Virginia, Massachusetts, Indiana, Wyoming, Illinois, South Carolina, Maine, Tennessee, North Carolina, Arizona and Utah.

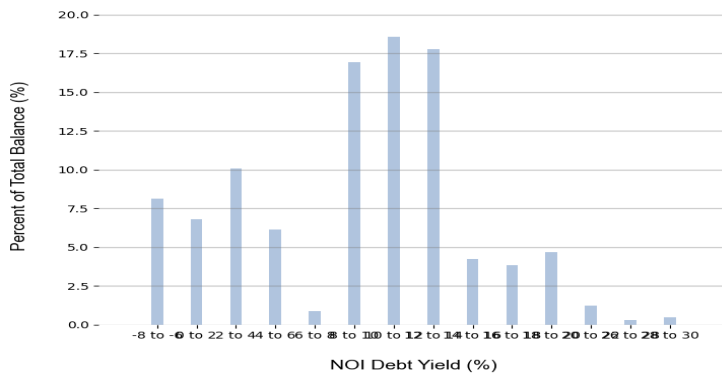

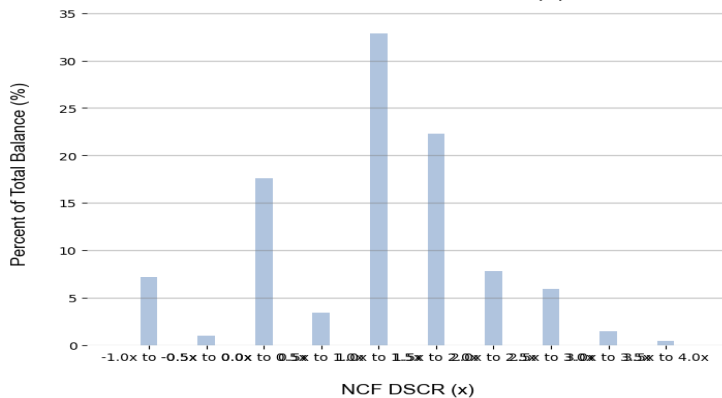
NOI Debt Yield (%)

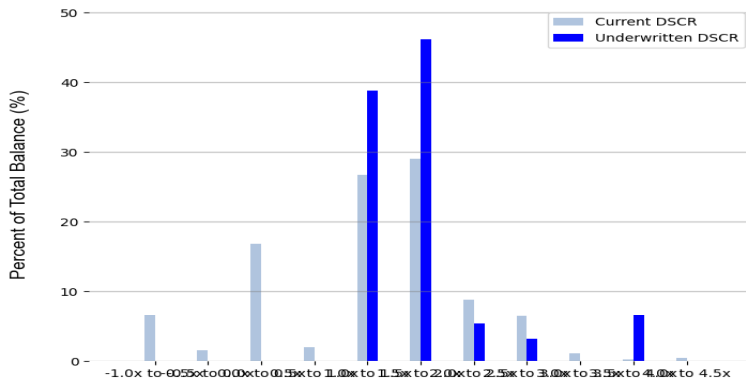
Net Cash Flow DSCR (x)

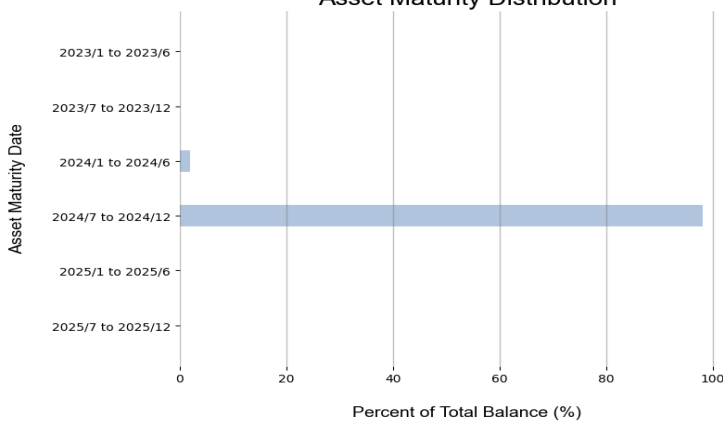
**DSCR Distribution (x)**



DSCRs ranged from -1.0x to 4.5x. There are 1 assets (6.6% of total balance) with DSCR between -1.0x and -0.5x, 2 assets (1.6% of total balance) with DSCR between -0.5x and 0.0x, 4 assets (16.9% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (2.1% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (26.8% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (29.0% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (8.8% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (6.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.2% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.3% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.5% of total balance) with DSCR between 4.0x and 4.5x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

### 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:


