## Transaction Summary

The transaction closed on Oct 30 2014 and matures in Sep 2034. The pool's current aggregate principal balance is \$1017.4 million compared to \$1090.0 million at close.

The largest loan of the pool (11.8%) is secured by Gateway Center Phase II located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included JC Penney (20.34%) and Big V Shoprite Supermarket (14.91%). The second largest loan of the pool (11.3%) is secured by InterContinental Miami located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 64%. The third largest loan of the pool (7.5%) is secured by Marriott Atlanta Airport Gateway located in metropolitan area. Occupancy at the subject was 74%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.53% and 73 months as of 10/10/2020, respectively. There are a total of 58 loans and 95 properties in the portfolio. The appraisal LTV was approximately 77.2% compared to the Original loan to value (LTV), which was approximately 65.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.03x. As of 10/10/2020, 0.58% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

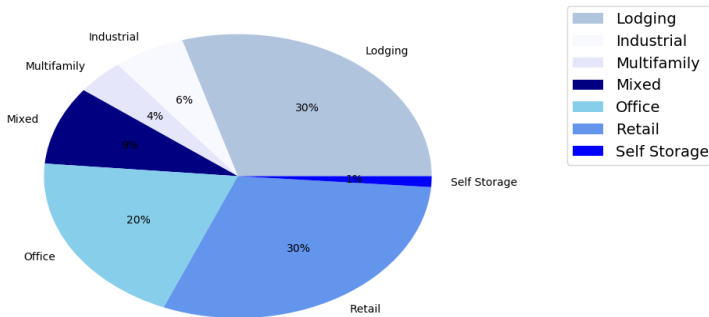

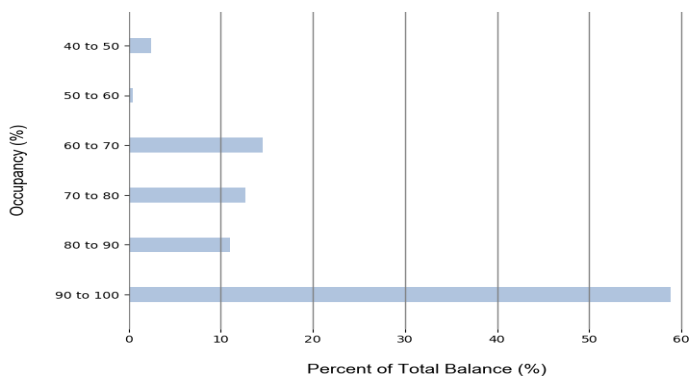

Occupancy Distribution (%)

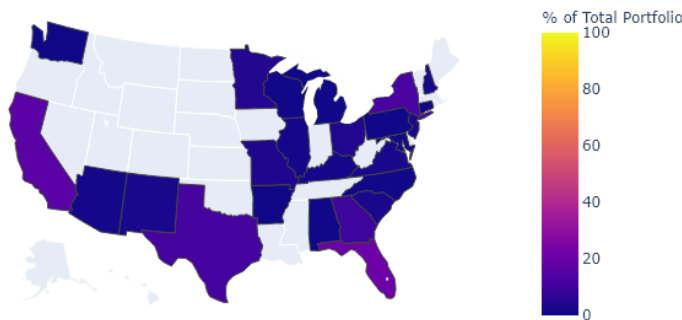

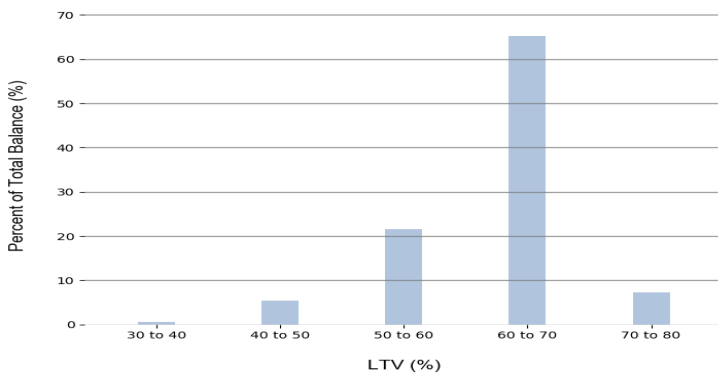
Local Distribution

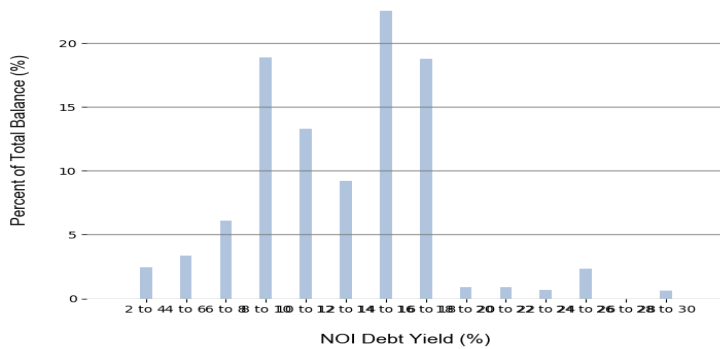

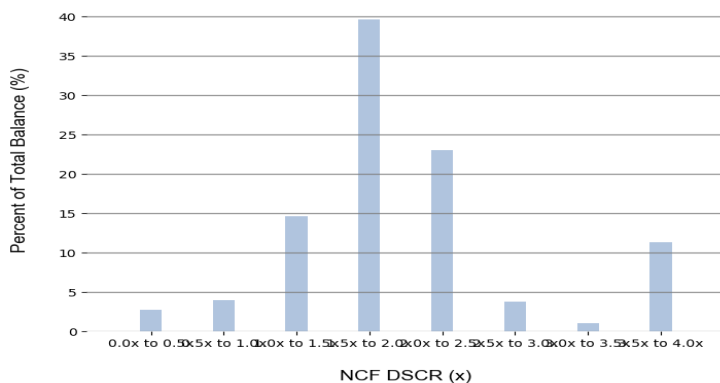
NOI Debt Yield (%)

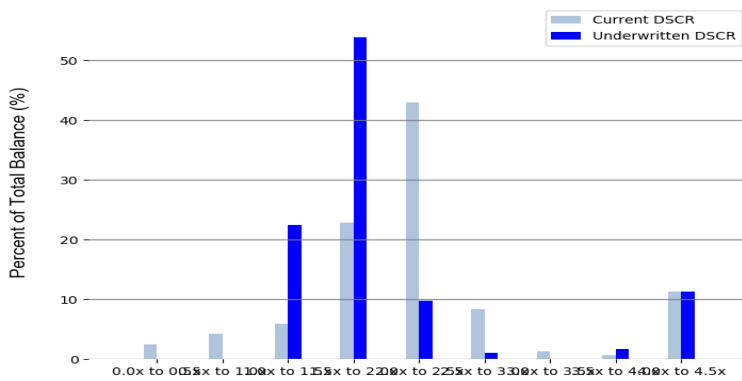

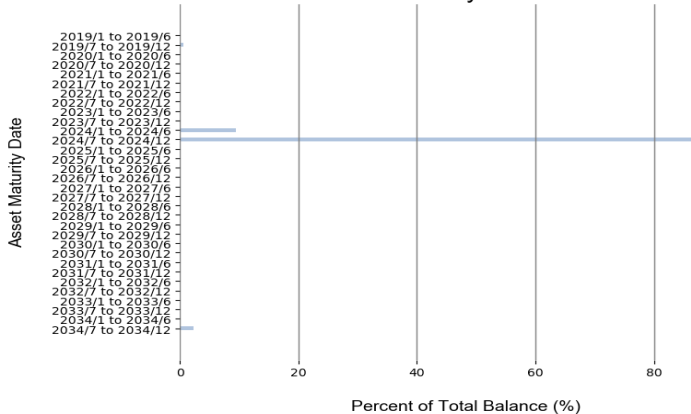
DSCR Distribution (x)

There are 1 assets (2.4% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (4.2% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (5.9% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (22.8% of total balance) with DSCR between 1.5x and 2.0x, 21 assets (43.0% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (8.4% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (11.3% of total balance) with DSCR between 4.0x and 4.5x. There are 1 assets (0.6% of total balance) that have maturity dates between 2019/7 and 2019/12, 4 assets (9.4% of total balance) that have maturity dates between 2024/1 and 2024/6, 52 assets (87.7% of total balance) that have maturity dates between 2024/7 and 2024/12 and 1 assets (2.3% of total balance) that have maturity dates between 2034/7 and 2034/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
