Transaction Summary

The transaction closed on Oct 30 2014 and matures in Sep 2034. The pool's current aggregate principal balance is \$929.2 million compared to \$1015.9 million at close.

The largest loan of the pool (12.9%) is secured by Gateway Center Phase II located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included JC Penney (20.34%) and Big V Shoprite Supermarket (14.91%). The second largest loan of the pool (12.4%) is secured by InterContinental Miami located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 20%. The third largest loan of the pool (7.9%) is secured by Marriott Atlanta Airport Gateway located in metropolitan area. Occupancy at the subject was 74%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.51% and 90 months as of 03/10/2022, respectively. There are a total of 53 loans and 90 properties in the portfolio. The appraisal LTV was approximately 65.7% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.49x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 80%.





Occupancy Distribution (%)




Local Distribution









DSCRs ranged from 0.0x to 4.5x.There are 1 assets (0.7% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (18.7% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (6.6% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (44.1% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (20.4% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (5.2% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.9% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (2.7% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.6% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
