#### Transaction Summary

The transaction closed on Dec 19 2014 and matures in Dec 2024. The pool's current aggregate principal balance is \$655.6 million compared to \$692.8 million at close.

The largest loan of the pool (12.2%) is secured by One Memorial located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 99%. The major tenants included INTERSYSTEMS CORP (64.06%) and Microsoft (42.32%). The second largest loan of the pool (9.2%) is secured by Loews Miami Beach Hotel located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 91%. The third largest loan of the pool (7.3%) is secured by King's Shops located in metropolitan area. Occupancy at the subject was 91%. The major tenants included ROY'S WAIKOLOA BAR & GRILL (7.24%) and FOSTER'S KITCHEN (6.18%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.45% and 73 months as of 12/10/2020, respectively. There are a total of 51 loans and 66 properties in the portfolio. The appraisal LTV was approximately 71.5% compared to the Original loan to value (LTV), which was approximately 64.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.96x. As of 12/10/2020, 1.72% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





#### Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 4% to 25%. There were 2 assets (7% of total balance) with NOI debt yield between 4% and 6%, 4 assets (14% of total balance) with NOI debt yield between 6% and 8%, 6 assets (15% of total balance) with NOI debt yield between 8% and 10%, 12 assets (15% of total balance) with NOI debt yield between 10% and 12%, 11 assets (25% of total balance) with NOI debt yield between 12% and 14%, 7 assets (16% of total balance) with NOI debt yield between 14% and 16%, 6 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (2% of total balance) with NOI debt yield between 18% and 20%, 2 assets (1% of total balance) with NOI debt yield between 24% and 26%

There were 1 assets (4.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (2.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (27.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 19 assets (27.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (9.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (3.5% of total balance) with NCF DSCR between 2.5x and 3.0x and 4 assets (24.8% of total balance) with NCF DSCR between 3.0x and 3.5x. 



DSCRs ranged from 0.5x to 4.0x.There are 2 assets (6.7% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (22.0% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (31.5% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (9.1% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (4.9% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (16.7% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (9.2% of total balance) with DSCR between 3.5x and 4.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
