Transaction Summary

The transaction closed on Dec 09 2013 and matures in Nov 2033. The pool's current aggregate principal balance is \$605.9 million compared to \$666.4 million at close.

The largest loan of the pool (11.6%) is secured by The Outlet Shoppes at Atlanta located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Saks Fifth Avenue (6.68%) and Nike Factory Store (3.69%). The second largest loan of the pool (12.1%) is secured by Miracle Mile Shops located in metropolitan area. Occupancy at the subject was 98%. The major tenants included V THEATER (8.56%) and SAXE THEATER (4.99%). The third largest loan of the pool (8.3%) is secured by One Union Square located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Bulgari (38.31%) and 180 Geary Street HQ LLC (23.06%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.13% and 86 months as of 12/10/2020, respectively. There are a total of 55 loans and 60 properties in the portfolio. The appraisal LTV was approximately 60.7% compared to the Original loan to value (LTV), which was approximately 63.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.73x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.






Local Distribution





Most recent net operating income debt yield ranged from 6% to 27% with a weighted average NOI debt yield of 12.5%. NOI debt yield ranged from 6% to 27%. There were 3 assets (5% of total balance) with NOI debt yield between 6% and 8%, 7 assets (26% of total balance) with NOI debt yield between 8% and 10%, 10 assets (15% of total balance) with NOI debt yield between 10% and 12%, 16 assets (34% of total balance) with NOI debt yield between 12% and 14%, 8 assets (7% of total balance) with NOI debt yield between 14% and 16%, 7 assets (7% of total balance) with NOI debt yield between 16% and 18%, 2 assets (4% of total balance) with NOI debt yield between 18% and 20%, 1 assets (2% of total balance) with NOI debt yield between 20% and 22%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%

NCF DSCR ranged from 0.0x to 4.0x. There were 2 assets (3.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 17 assets (34.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 25 assets (49.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (6.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.8% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (2.6% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 1.7x.







DSCRs ranged from 0.5x to 4.5x.There are 2 assets (3.4% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (19.3% of total balance) with DSCR between 1.0x and 1.5x, 28 assets (55.9% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (13.4% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (4.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.7% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (2.6% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
