Transaction Summary

The transaction closed on Mar 20 2014 and matures in Mar 2024. The pool's current aggregate principal balance is \$687.6 million compared to \$769.5 million at close.

The largest loan of the pool (11.3%) is secured by CityScape - East Office/Retail located in metropolitan area. Occupancy at the subject was 85%. The major tenants included Alliance Bank of Arizona (25.39%) and United HealthCare (14.27%). The second largest loan of the pool (5.9%) is secured by Independence Green Apartments located in Warren-Troy-Farmington Hills, MI metropolitan area. Occupancy at the subject was 92%. The third largest loan of the pool (4.7%) is secured by Biltmore Office located in metropolitan area. Occupancy at the subject was 81%. The major tenants included Kimley-Horn & Associates, Inc. (12.26%) and SOUTHSTAR ENERGY SERV (10.63%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.11% and 99 months as of 04/10/2022, respectively. There are a total of 67 loans and 82 properties in the portfolio. The appraisal LTV was approximately 61.7% compared to the Original loan to value (LTV), which was approximately 67.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.47x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





Occupancy Distribution (%)





Local Distribution







Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 12.6%. NOI debt yield ranged from 4% to 25%. There were 1 assets (4% of total balance) with NOI debt yield between 4% and 6%, 2 assets (3% of total balance) with NOI debt yield between 6% and 8%, 8 assets (23% of total balance) with NOI debt yield between 8% and 10%, 15 assets (20% of total balance) with NOI debt yield between 10% and 12%, 13 assets (17% of total balance) with NOI debt yield between 12% and 14%, 10 assets (12% of total balance) with NOI debt yield between 14% and 16%, 5 assets (10% of total balance) with NOI debt yield between 16% and 18%, 5 assets (4% of total balance) with NOI debt yield between 18% and 20%, 3 assets (2% of total balance) with NOI debt yield between 20% and 22%, 3 assets (2% of total balance) with NOI debt yield between 22% and 24% and 2 assets (2% of total balance) with NOI debt yield between 24% and NCF DSCR ranged from 0.0x to 3.5x. 



DSCRs ranged from 0.0x to 3.5x.There are 1 assets (3.6% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (8.1% of total balance) with DSCR between 0.5x and 1.0x, 12 assets (24.1% of total balance) with DSCR between 1.0x and 1.5x, 27 assets (33.4% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (21.3% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (6.9% of total balance) with DSCR between 2.5x and 3.0x and 4 assets (2.7% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
