## **Transaction Summary**

The transaction closed on May 22 2014 and matures in Apr 2044. The pool's current aggregate principal balance is \$757.1 million compared to \$814.8 million at close.

The largest loan of the pool (16.5%) is secured by Maine Mall located in metropolitan area. Occupancy at the subject was 76%. The major tenants included JC Penney (11.76%) and Best Buy (6.27%). The second largest loan of the pool (5.6%) is secured by Greene Town Center located in metropolitan area. Occupancy at the subject was 93%. The major tenants included LA Fitness (7.24%) and Nordstrom (4.95%). The third largest loan of the pool (6.0%) is secured by 636 Greenwich Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.97% and 80 months as of 12/10/2020, respectively. There are a total of 58 loans and 74 properties in the portfolio. The appraisal LTV was approximately 62.3% compared to the Original loan to value (LTV), which was approximately 66.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.63x. As of 12/10/2020, 1.28% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.






#### Local Distribution





Most recent net operating income debt yield ranged from 6% to 23% with a weighted average NOI debt yield of 11.4%. NOI debt yield ranged from 6% to 23%. There were 4 assets (8% of total balance) with NOI debt yield between 6% and  $8\%,\ 8$  assets (33% of total balance) with NOI debt yield between 8% and 10%, 16 assets (27% of total balance) with NOI debt yield between 10% and 12%, 12 assets (13% of total balance) with NOI debt yield between 12% and 14%, 8 assets (6% of total balance) with NOI debt yield between 14% and 16%, 6 assets (6% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%, 2 assets (2% of total balance) with NOI debt yield between 20% and 22% and 1 assets (5% of total balance) with NOI debt yield between 22% and 24%.

NCF DSCR ranged from 0.0x to 4.0x. There were 3 assets (6.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 23 assets (39.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 19 assets (36.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (12.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (5.8% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.5% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 1.6x.







DSCRs ranged from 0.5x to 4.5x.There are 3 assets (6.1% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (24.5% of total balance) with DSCR between 1.0x and 1.5x, 27 assets (49.4% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (13.7% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (5.8% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.5% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 1.7x.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
