Transaction Summary

The transaction closed on May 22 2014 and matures in Apr 2044. The pool's current aggregate principal balance is \$703.4 million compared to \$772.7 million at close.

The largest loan of the pool (17.8%) is secured by Maine Mall located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Jordan Furniture Gallery LLC (16.39%) and JC Penney (11.76%). The second largest loan of the pool (5.9%) is secured by Greene Town Center located in metropolitan area. Occupancy at the subject was 94%. The major tenants included LA Fitness (7.24%) and Nordstrom (4.95%). The third largest loan of the pool (6.5%) is secured by 636 Greenwich Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.97% and 95 months as of 03/10/2022, respectively. There are a total of 54 loans and 70 properties in the portfolio. The appraisal LTV was approximately 61.6% compared to the Original loan to value (LTV), which was approximately 66.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.51x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

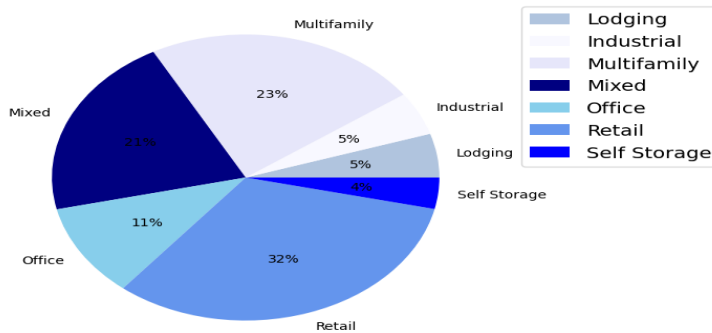

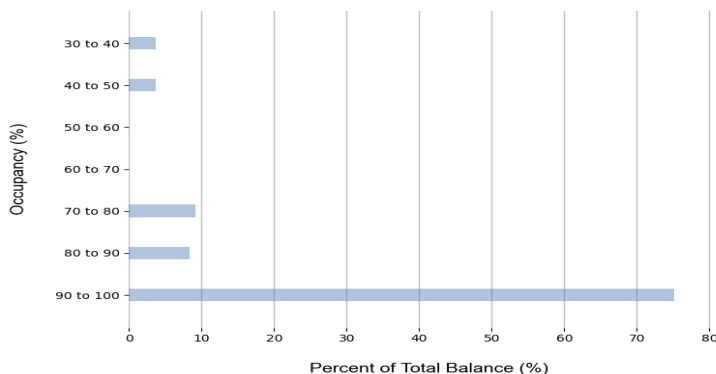

Occupancy Distribution (%)

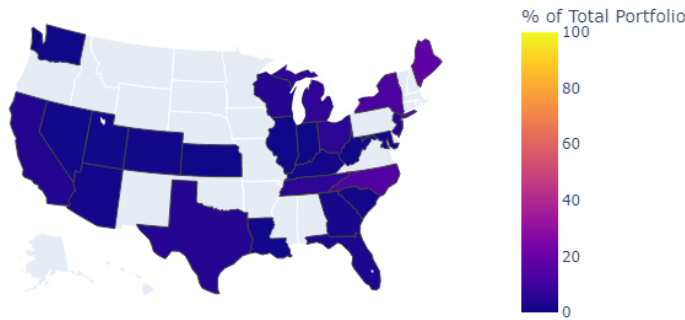

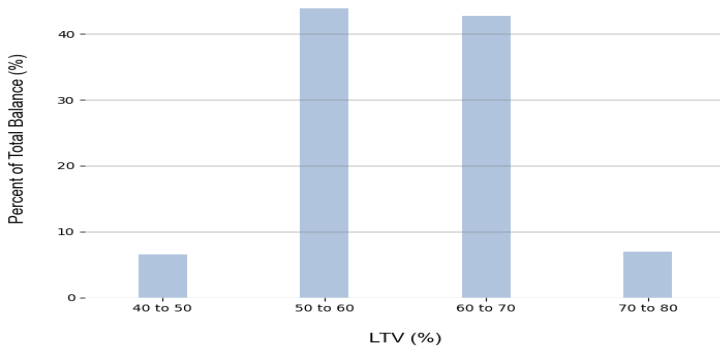
Local Distribution

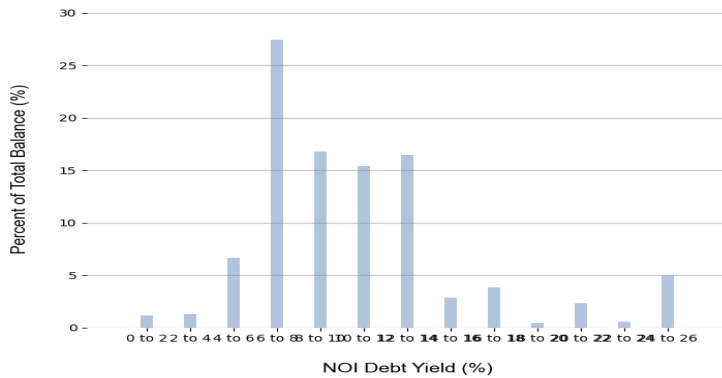

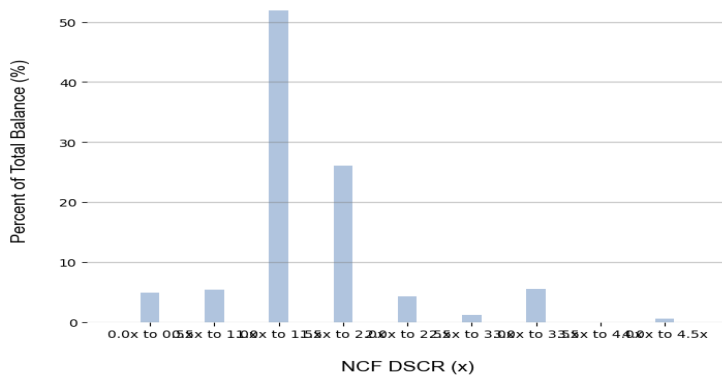
NOI Debt Yield (%)

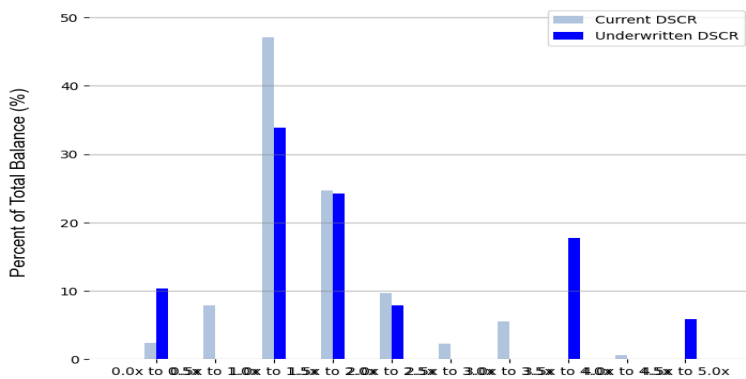

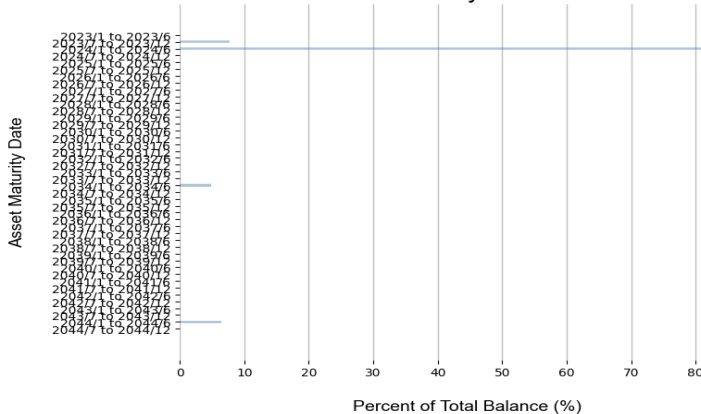
DSCR Distribution (x)



DSCRs ranged from 0.0x to 4.5x. There are 2 assets (2.4% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (7.9% of total balance) with DSCR between 0.5x and 1.0x, 17 assets (47.1% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (24.6% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (9.7% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (2.2% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (5.5% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.6% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
