Transaction Summary

The transaction closed on Aug 07 2014 and matures in Jul 2024. The pool's current aggregate principal balance is \$1013.2 million compared to \$1073.9 million at close.

The largest loan of the pool (13.8%) is secured by 28-40 West 23rd Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 91%. The major tenants included ARAMIS INC (42.10%) and AT&T SERVICES INC (38.36%). The second largest loan of the pool (9.6%) is secured by Selig Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 97%. The major tenants included Amazon.com (17.64%) and Sound Transit (5.57%). The third largest loan of the pool (8.2%) is secured by Hyatt NYC Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 97%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.50% and 75 months as of 10/10/2020, respectively. There are a total of 66 loans and 77 properties in the portfolio. The appraisal LTV was approximately 58.1% compared to the Original loan to value (LTV), which was approximately 60.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.33x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.



Type Concentration









Among assets in the portfolio, there are 6 properties (26% of total balance) located in New York, 5 properties (16% of total balance) in California, 8 properties (10% of total balance) in Washington, 4 properties (7% of total balance) in Tennessee, 3 properties (7% of total balance) in Maryland, 5 properties (6% of total balance) in Florida, 3 properties (4% of total balance) in North Carolina, 6 properties (4% of total balance) in Virginia and 7 properties (4% of total balance) in Texas. Other properties are located in the state of Texas, Indiana, Louisiana, West Virginia, Pennsylvania, Washington DC, North Dakota, Nevada, Michigan, Alabama, Georgia, Illinois, Arizona, Connecticut, Ohio, Mississippi, New Hampshire, Colorado, Idaho, Utah and Kentucky.







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
