Transaction Summary

The transaction closed on Aug 07 2014 and matures in Jul 2024. The pool's current aggregate principal balance is \$916.4 million compared to \$997.4 million at close.

The largest loan of the pool (15.3%) is secured by 28-40 West 23rd Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included ARAMIS INC (41.60%) and AT&T SERVICES INC (37.90%). The second largest loan of the pool (10.6%) is secured by Selig Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 88%. The major tenants included AMAZON.COM SERVICES INC (17.65%) and SOUND TRANSIT (5.57%). The third largest loan of the pool (8.8%) is secured by Hyatt NYC Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 97%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.50% and 92 months as of 03/10/2022, respectively. There are a total of 61 loans and 72 properties in the portfolio. The appraisal LTV was approximately 56.7% compared to the Original loan to value (LTV), which was approximately 59.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.13x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)






Local Distribution









DSCRs ranged from -0.5x to 5.5x. There are 1 assets (0.5% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (0.5% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (5.0% of total balance) with DSCR between 0.5x and 1.0x, 16 assets (27.7% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (30.5% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (17.2% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (2.0% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (0.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.5% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (15.3% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.
