## **Transaction Summary**

The transaction closed on Feb 09 2015 and matures in Jan 2045. The pool's current aggregate principal balance is \$1080.2 million compared to \$1138.6 million at close.

The largest loan of the pool (9.0%) is secured by Kemper Lakes Business Center located in Lake County-Kenosha County, IL-WI metropolitan area. Occupancy at the subject was 89%. The major tenants included Fresenius Medical (33.69%) and Dovenmuehle Mortgage Inc (22.24%). The second largest loan of the pool (8.8%) is secured by 393-401 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included AEO MANAGEMENT CO. (88.16%) and DORFMAN PACIFIC INC (2.29%). The third largest loan of the pool (4.8%) is secured by Northeastern Hotel Portfolio located in New York-Jersey City-White Plains, NY-NJ-51.64% metropolitan area. Occupancy at the subject was 80%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.44% and 72 months as of 12/10/2020, respectively. There are a total of 95 loans and 110 properties in the portfolio. The appraisal LTV was approximately 67.8% compared to the Original loan to value (LTV), which was approximately 67.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.88x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



Type Concentration













Most recent net operating income debt yield ranged from 2% to 19% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 2% to 19%. There were 2 assets (2% of total balance) with NOI debt yield between 2% and 4%, 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 2 assets (1% of total balance) with NOI debt yield between 6% and 8%, 29 assets (33% of total balance) with NOI debt yield between 8% and 10%, 25 assets (23% of total balance) with NOI debt yield between 10% and 12%, 18 assets (29% of total balance) with NOI debt yield between 12% and 14%, 9 assets (5% of total balance) with NOI debt yield between 14% and 16%, 7 assets (3% of total balance) with NOI debt yield between 16% and 18% and 2 assets (0% of total balance) with NOI debt yield between 18% and 20%.



There were 2 assets (1.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (4.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 28 assets (25.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 33 assets (33.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 20 assets (14.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (18.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (3.0% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.4% of total balance) with NCF DSCR between 4.0x and 4.5x. 

DSCRs ranged from 2.5x to 4.5x. There are 6 assets (11.2% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (13.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.4% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.0x. Underwritten DSCR is not available.

There are 1 assets (1.6% of total balance) that have maturity dates between 2021/7 and 2021/12, 64 assets (74.9% of total balance) that have maturity dates between 2024/7 and 2024/12, 26 assets (22.1% of total balance) that have maturity dates between 2025/1 and 2025/6, 1 assets (0.7% of total balance) that have maturity dates between 2029/7 and 2029/12 and 3 assets (0.7% of total balance) that have maturity dates between 2045/1 and 2045/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
