Transaction Summary

The transaction closed on Feb 09 2015 and matures in Jan 2045. The pool's current aggregate principal balance is \$1026.4 million compared to \$1105.9 million at close.

The largest loan of the pool (9.3%) is secured by Kemper Lakes Business Center located in Lake County-Kenosha County, IL-WI metropolitan area. Occupancy at the subject was 95%. The major tenants included Fresenius Medical (33.66%) and Dovenmuehle Mortgage Inc (23.44%). The second largest loan of the pool (9.3%) is secured by 393-401 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included AEO MANAGEMENT CO. (88.16%) and DORFMAN PACIFIC INC (2.29%). The third largest loan of the pool (4.9%) is secured by Northeastern Hotel Portfolio located in New York-Jersey City-White Plains, NY-NJ-51.64% metropolitan area. Occupancy at the subject was 54%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.44% and 88 months as of 04/10/2022, respectively. There are a total of 92 loans and 104 properties in the portfolio. 

Type Concentration








Local Distribution








