Transaction Summary

The transaction closed on Apr 15 2015 and matures in Apr 2025. The pool's current aggregate principal balance is \$902.2 million compared to \$953.1 million at close.

The largest loan of the pool (13.9%) is secured by Selig Office Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 93%. The major tenants included Washington State Ferries (5.37%) and ZipWhip Inc. (4.59%). The second largest loan of the pool (12.2%) is secured by 160 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was The Simons Foundation (100.00%). The third largest loan of the pool (11.1%) is secured by 3 Columbus Circle located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included Y&R (30.31%) and Emerge212 (10.91%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.16% and 85 months as of 04/10/2022, respectively. There are a total of 78 loans and 96 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 64.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.37x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
