## **Transaction Summary**

The transaction closed on Jul 08 2015 and matures in May 2030. The pool's current aggregate principal balance is \$686.4 million compared to \$717.8 million at close.

The largest loan of the pool (14.6%) is secured by 135 South LaSalle located in metropolitan area. Occupancy at the subject was 88%. The major tenants included Bank Of America (60.19%) and Bank Of America (1.83%). The second largest loan of the pool (10.5%) is secured by Selig Office Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 95%. The major tenants included Washington State Ferries (5.30%) and Emeritus Corporation (4.63%). The third largest loan of the pool (9.4%) is secured by Dallas Market Center located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 79%. The major tenants included The L.D. Kichler Company (0.77%) and Generation Brands LLC dba Murray Feiss Imports and Monte Carlo Fans (0.76%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.07% and 65 months as of 10/10/2020, respectively. There are a total of 49 loans and 75 properties in the portfolio. The appraisal LTV was approximately 58.2% compared to the Original loan to value (LTV), which was approximately 59.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.58x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



**Type Concentration** 











Most recent net operating income debt yield ranged from 4% to 23% with a weighted average NOI debt yield of 12.3%. NOI debt yield ranged from 4% to 23%. There were 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 4 assets (8% of total balance) with NOI debt yield between 6% and 8%, 6 assets (22% of total balance) with NOI debt yield between 8% and 10%, 17 assets (33% of total balance) with NOI debt yield between 10% and 12%, 7 assets (11% of total balance) with NOI debt yield between 12% and 14%, 5 assets (4% of total balance) with NOI debt yield between 14% and 16%, 5 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (15% of total balance) with NOI debt yield between 18% and 20%, 2 assets (1% of total balance) with NOI debt yield between 20% and 22% and 1 assets (1% of total balance) with NOI debt yield between 22% and 24%.

NCF DSCR ranged from 0.0x to 5.0x. There were 1 assets (0.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (18.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (30.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (25.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (3.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (4.4% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.9% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (1.3% of total balance) with NCF DSCR between 4.0x and 4.5x, 1 assets (0.7% of total balance) with NCF DSCR between 4.5x and 5.0x and 1 assets (14.6% of total balance) with NCF DSCR between 5.0x and 5.5x. 



DSCRs ranged from 0.5x to 6.0x.There are 1 assets (0.9% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (12.5% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (32.9% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (20.8% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (8.8% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (3.9% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (2.8% of total balance) with DSCR between 3.5x and 4.0x, 2 assets (2.2% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (0.7% of total balance) with DSCR between 5.0x and 5.5x and 1 assets (14.6% of total balance) with DSCR between 5.5x and 6.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
