Transaction Summary

The transaction closed on Jul 08 2015 and matures in May 2030. The pool's current aggregate principal balance is \$660.1 million compared to \$702.9 million at close.

The largest loan of the pool (15.1%) is secured by 135 South LaSalle located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Kaufman Dolowich & Voluck LLP (1.42%) and Bank Of America (1.10%). The second largest loan of the pool (10.9%) is secured by Selig Office Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 91%. The major tenants included Washington State Ferries (5.37%) and ZipWhip Inc. (4.59%). The third largest loan of the pool (9.5%) is secured by Dallas Market Center located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 85%. The major tenants included Goetz Inc. (1.13%) and K. Graves & A. Graves Inc. (0.87%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.06% and 82 months as of 03/10/2022, respectively. There are a total of 47 loans and 73 properties in the portfolio. The appraisal LTV was approximately 64.4% compared to the Original loan to value (LTV), which was approximately 59.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.40x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 11.8%. NOI debt yield ranged from 4% to 21%. There were 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 6 assets (18% of total balance) with NOI debt yield between 6% and 8%, 7 assets (30% of total balance) with NOI debt yield between 8% and 10%, 9 assets (16% of total balance) with NOI debt yield between 10% and 12%, 10 assets (11% of total balance) with NOI debt yield between 12% and 14%, 7 assets (4% of total balance) with NOI debt yield between 14% and 16%, 5 assets (5% of total balance) with NOI debt yield between 16% and 18%, 1 assets (15% of total balance) with NOI debt yield between 18% and 20% and 1 assets (1% of total balance) with NOI debt yield between 20% and 22%.

NCF DSCR ranged from 0.5x to 5.0x. There were 1 assets (0.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (35.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (24.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (7.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (11.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (3.4% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.9% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (1.4% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (15.1% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.5x to 5.5x.There are 1 assets (0.9% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (28.2% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (26.4% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (9.1% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (13.9% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (4.1% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (2.2% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (15.1% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
